The Chairman, Ms. Marian Martin, called the meeting to order.

Ms. Martin asked if there were any changes to the minutes of the Board meeting on November 16, 2022. The minutes were approved as presented.

Mr. Patterson informed the Board that Mr. Hughes is out today. Residential reassessment is 98 percent complete with an average increase of 13 percent. Commercial reassessment is 60 percent complete with an average increase of 5 percent. Two residential appraisers were hired and will start on December 19th. A deed reader was hired and will start January 3rd. The office will have a full team starting in January.
