Update #1

(Henrico County, Va.) – On Thursday, January 5, 2023, the Emergency Communications Center received an emergency call just after 2:30 a.m. for a single-vehicle crash along the 5700 block of Audubon Drive. The Henrico Division of Fire and the Henrico County Police Division responded to the scene. The single vehicle was occupied by two adults, an adult male driver, and a female passenger. The adult male was transported to an area hospital with critical injuries, while the adult female succumbed to her injuries on the scene.

Rebecca Anne Smith, 28, of Henrico County, was identified as the female passenger of the 2005 Ford Crown Victoria involved in the crash. Our thoughts are with the family and friends of Ms. Smith, and everyone involved during this tragic incident.

Detectives from the Henrico County Crash team responded to the scene to investigate. While they are in the early stages of their investigation, speed and no seat belts are believed to be factors in the crash. Detectives will continue to work closely with the State's Office of the Chief Medical Examiner and the Henrico County Commonwealth's Attorney's Office throughout this thorough investigation.

Henrico Police remind drivers to obey speed limits, drive sober, and avoid distracted driving. All occupants are reminded to buckle up before traveling anywhere. We want everyone to arrive safely. The Henrico CRASH team responded and is conducting an investigation into the cause of the accident.

Henrico Police Arrest Driver in Fatal Crash; Reminding Everyone to Buckle-Up

Update #2

(Henrico County, Va.) – Henrico Police determined that the driver, <u>30-year-old Shakeem Walker</u> of Henrico, who was involved in the fatal crash along Audubon Drive, had left the hospital during the morning hours on Thursday, January 5, 2023. Detectives from the Henrico County Crash Team obtained a warrant for involuntary manslaughter related to the crash.

Later that afternoon, officers located and took Walker into custody near the intersection of Meadowspring Road and Laburnum Avenue. Walker was booked at the Henrico County Jail, where he remains held without bond.

The investigation remains active, while working alongside the Commonwealth's Attorney's Office and the Office of the State's Medical Examiner.

Crews worked to extricate the driver from the crash scene and render aid but succumbed to his injuries on the scene. **Yunior Morales Garcia**, **32**, of Henrico County, was identified as the driver and sole occupant of the vehicle. Our thoughts are with his family and friends while they process this untimely death.

While the crash remains under investigation, speed, and failure to wear a seatbelt are all factors considered in this investigation. Henrico Police remind all motorists to obey the rules of the road, including speed limits and safety restraints, and avoid distracted or impaired driving.

Hampton Man Charged in Overnight Incident

(Henrico County, Va.) – Henrico Police have identified and placed charges against the man encountered during an early morning call along Richmond-Henrico Turnpike. Mark P. Failey, **31, of Hampton, Va**. was released from the hospital and transported to the Henrico County Sheriff's Office, where he was booked and held without bond on the following charges:

- 1. Assault on law enforcement
- 2. Obstruction of justice

The Officer-Involved Investigations Team investigates any discharge of a firearm by a Police Division member. The Police Division will continue the investigation and work closely with the Henrico Commonwealth Attorney's Office.

Juvenile Taken into Custody with Firearm on School Campus

(Henrico County, Va.) – On Friday, January 20, 2023, just before 11:00 a.m., a Henrico Police School Resource Officer (SRO) was onsite at Holman Middle School, located at 600 Concourse Boulevard when he was alerted by school administration of a weapon on school grounds.

Both the administrator and officer responded to investigate the anonymous tip submitted to Henrico County School (HCPS) personnel as they were also working to take the juvenile into custody. The male juvenile was not cooperative, and a struggle ensued among them. The SRO summoned for additional assistance, prompting a large police presence at the school this afternoon. Our partners with the Division of Fire responded to medically clear the juvenile and officer out of precaution. There were no reported injuries.

The juvenile, whose identity is not being provided due to his age was transported and admitted to the Henrico County Juvenile Detention Home on violations of:

- Possession of a firearm on school property,
- Possession of a concealed firearm, and
- Underage possession of a firearm.

"The safety of our students, faculty, and first responders are paramount," said **Henrico Police Lieutenant Matt Pecka**. We are appreciative of the partnership between the Police Division, HCPS, and our community for understanding the necessary need for responses like today to ensure the safety of all. We further commend those who come forward and report incidents like today to authorities whether in person or through tip lines in place to remain anonymous."

Henrico Police Encounters First Rabies Case of 2023

(Henrico County, Va.) – On Friday, January 27, 2023, Henrico Police responded to the 400 block of Brookside Blvd in the Fairfield District for a potential rabies exposure involving a dog and a raccoon. It was reported that the raccoon came through the dog door of the residence and had a physical altercation with the dog.

The raccoon was submitted to the State Lab and tested positive for rabies. Because there was contact between the dog and the raccoon, the dog will be quarantined on the owner's property. There were no additional animal or human exposures reported. This is the first confirmed rabies case in Henrico County for 2023.

The Henrico Police Animal Protection Unit reminds everyone to keep their pets' rabies vaccinations current to ensure the safety of their pets and our community. Henrico County offers rabies vaccination clinics throughout the year. The <u>next rabies clinic</u> will be held on February 25, 2023, from 9:00 a.m. to 12:00 p.m., at the Henrico County Western Government Center, located on Parham Road. These vaccinations cost \$15.00 and are cash only. Additional rabies clinic dates can be found on the <u>Henrico</u> <u>County Animal Shelter's page</u>.

HPD Investigates Fatal Crash; Seeking Witnesses & Driver Involved

(Henrico County, Va.) – On Tuesday, January 31, 2023, Henrico Police and Fire responded to the eastbound lanes of the 7900 block of W. Broad Street, just before 6:30 p.m., for a fatal hit-and-run pedestrian crash involving a pickup truck. The crash closed the center and right lanes while crash team investigators collected evidence and documented the crash. Traffic was restored back to normal just after 9 p.m.

Emergency care was rendered, and the pedestrian was transported to the hospital with lifethreatening injuries. **Trinesse Robinson, 49**, succumbed to her injuries at the hospital.

Homicide Investigation: Suspect Arrested

Update 1:

(Henrico County, Va.) – Into the evening hours, Sunday, February 19, 2023, Detectives continued their investigation into the untimely death of a Henrico man at the intersection of Rhudy Street and Hargrove Avenue.

The victim, Michael Stevens, 40, of Henrico County, was pronounced at the scene.

Juveniles Face Consequences For False Summonsing of First Responders

(Henrico County, Va.) – On Wednesday, April 19, 2023, the investigation continued into the mass response by first responders Tuesday afternoon after a call over radios prompted school leaders to go into a lock and hide status until police, out of an abundance of caution, could sweep the school ensuring everyone was safe.

Through the investigation, Henrico Police have identified **one juvenile male and female, both 7**th**grade students** for their involvement, prompting a unified response from police and fire officials. Both students were issued a juvenile violation report (JVR) for violating the Code of Virginia Statute **18.2-461 – Falsely summoning law enforcement, a class one misdemeanor**. The juveniles were released to their parents pending a review from the juvenile justice system.

"The safety of our students, faculty, and first responders is of utmost importance," said Henrico Police Lieutenant Matt Pecka. "We appreciate the partnership between the Police Division, Henrico County Public Schools, the Division of Fire, and our community for understanding the necessary need for not only the response but the protective sweeps like yesterday to ensure the safety of everyone."

Driver Charged in Crash with Richmond Police in Henrico County

(Henrico County, Va.) – Henrico Police have charged a Richmond man with attempted aggravated murder for a May 2nd crash involving Richmond Police.

On Tuesday, May 2, 2023, the Henrico Police Crash Team responded to the intersection of Deane Road and Rodney Road for a reported crash between a cement truck and Richmond Police.

The preliminary investigation shows an assault and abduction occurred in the 6500 block of Van Ness Place (Henrico County) shortly after 5 p.m. on Saturday, June 10, 2023. The suspect, identified as **Dana Paul Roman, 45, of Henrico,** then drove with the individual to Fairfax County and was involved in a shooting there. The victim, who is known to Roman, was taken to an area hospital for their injuries.

In the early morning hours of Sunday, June 11, 2023, Fairfax County Police initiated an investigation into a series of violent incidents including another abduction and a carjacking in that jurisdiction. More information on Fairfax County's incident can be <u>found here</u>.

On Monday, June 12, 2023, at approximately 3 a.m., Roman was located in Henrico County and a pursuit was initiated. He later fled on foot and the pursuit was terminated. At approximately 8:56 a.m. Henrico Police located the suspect vehicle in the area of Laburnum Avenue and Interstate 64. Another pursuit was initiated, ultimately crossing into the City of Richmond which involved a crash off Glenwood Avenue. Roman then fled on foot.

HCPD was able to locate Roman, who was armed with a gun, in the area of N. 35th Street and E. Marshall Street where he died from a self-inflicted gunshot wound.

Henrico Police continues to work with the <u>Richmond Police Department</u>, <u>who will handle the</u> <u>death investigation</u>, and Fairfax County Police Department regarding this multi-jurisdiction case.

'Leaving One Teen Dead and an Adult Wounded'

Update 1:

(Henrico County, Va.) – On Saturday, June 17, 2023, Henrico Police responded to the 5300 block of Jennifer Pond Way at approximately 10:00 p.m. for a loud party coming from a residence. Upon officers' arrival, there was an estimated 100 vehicles in this Henrico community. Just before 10:30 p.m., officers gave advice and were working to clear the area.

At approximately 11:00 p.m., additional calls were received to the same home and nearly 10 minutes later, there were additional reports of people fighting and a shooting.

This prompted a large police presence due to the number of people in the area. Two victims were located, one juvenile teen female, and an adult male. Both were transported to the hospital, where the juvenile teen later died because of her injuries. The adult male sustained non-life-threatening injuries.

Her identity is being withheld due to her age. Henrico Police will work alongside the State Office of the Chief Medical Examiner to determine exact cause of death.

"There were a lot of people at this gathering, some of which may have details which may help detectives in the case," says Lieutenant Matt Pecka. "Whether you have knowledge, video, or any details connecting those who are responsible, come forward and share the information anonymously."



Juvenile Male Charged in Carjacking Leading to Fatal Crash

(Henrico County, Va.) – Henrico Police has obtained several petitions, including felony murder, for a juvenile male in connection to a fatal crash Monday night.

On Monday, August 7, 2023, at approximately 10:34 p.m., Henrico Police responded to the 4300 block of Lakefield Mews Drive for a reported carjacking.

Once on scene, officers spoke with the complainant who stated he was approached by a masked male who brandished a firearm. The suspect then got inside the victim's vehicle and fled the scene.

Officers were able to locate the vehicle and a pursuit was initiated. As the suspect vehicle was traveling on Williamsburg Road (Rt. 60) at a high rate of speed, the driver struck a bicyclist from behind. The suspect vehicle crashed into a utility pole and stopped near Williamsburg Road and Millers Lane. The driver of the vehicle was taken into custody and identified as a juvenile male. A firearm was recovered. The juvenile was transported to an area hospital for injuries and later discharged into police custody.

Henrico County Joint Statement Regarding Aug. 12 Incident

(Henrico County, Va.) – Over the last week Henrico Police along with multiple agencies within Henrico County have heard concerns from our community members about Saturday morning's escaped inmate incident from St. Mary's Hospital. We recognize the concerns everyone has brought forth regarding when the reverse 911 was issued and the ongoing search for the inmate by Virginia State Police, the Virginia Department of Corrections and U.S. Marshals Office.

On Saturday, August 12, at approximately 5:47 a.m., Henrico Police responded to the 5800 block of Bremo Road for a reported suspicious situation. Once on scene, officers were made aware of a Virginia Department of Corrections (VDOC) inmate who had escaped from the location. In an assisting role to the VDOC, more than 40 units within the Henrico County Police Division (HCPD) were dispatched to the area and immediately began searching for the state inmate, identified as Naseem Roulack.

Henrico Police requested that Richmond Police be notified about this incident. The Henrico County Department of Emergency Communications (DEC) called the Richmond Department of Emergency Communications at 6:05 a.m. for notification.

A perimeter for a search was created in the immediate area around the hospital. As patrols continued their search, information was received about a possible sighting, however no description of the individual was available. During this time, multiple other resources were requested within the County, and to surrounding jurisdictions, to respond to the location, including a tracking canine, and air support.

At approximately 8:10 a.m., Henrico Police made a request for a reverse 911. There was reason to believe at that time Mr. Roulack may have still been in a neighborhood nearby. The Henrico County Office of Emergency Management was contacted and started the process for a reverse 911 across a three-mile radius from the incident location. That alert was pushed out at 8:37 a.m. to residents and businesses within the geographical area.

When an alert is sent as an emergency, as this one was, people will get the alert regardless of signing up for anything unless they have turned emergency alerts off on their phone. People can also sign up to receive the alerts as well as more routine communications on the Everbridge app. More information about Henrico County's Alert System can be <u>found here</u>.

Henrico Police Addresses Misinformation from Highland Springs HS Incident

(Henrico County, Va.) – Due to misinformation on social media regarding an Aug. 28 incident at Highland Springs High School, which includes allegations of an arrest, dispatched police response and excessive force, the Henrico County Police Division is issuing the following statement for clarification purposes.

On Monday, August 28, 2023, a Henrico Police School Resource Officer (SRO), assigned to Highland Springs High School, observed a disturbance at the school involving a juvenile male student exhibiting confrontational behavior with a school administrator. The SRO monitored the ongoing situation until the student became confrontational again and uncooperative with school staff. He was detained for investigatory purposes.

During this encounter with Henrico Police, the student reported a minor injury to a finger, but declined treatment. This injury was documented. The Division was not made aware of any other possible injuries to the student until several days later.

Please note, this student was never arrested by Henrico Police. The Division is unable to speak to the Henrico County Public Schools' <u>Code of Student Conduct</u>.

Currently, Henrico Police is conducting an internal investigation of the incident. No additional details will be released at this time.

Charges Pending in School Fights, Two-Vehicle Crash

(Henrico County, Va.) – On Friday, September 15, 2023, at approximately 4:11 p.m., Henrico Police School Resource Officers (SRO) assigned to Highland Springs High School were alerted to a fight that broke out following a pep rally at the school. To de-escalate the altercation involving multiple students, an SRO deployed OC spray to the group. Two juveniles suffered minor injuries from the fight and were seen by the school nurse.

Shortly after this occurred, other fights broke out including in a nearby shopping center parking lot. Multiple other officers were dispatched to the school to address this active situation.

At approximately 4:27 p.m., a two-vehicle crash occurred in the nearby shopping center parking lot along Airport Drive.

The preliminary investigation shows the driver of an SUV sped through the parking lot and struck a United States Postal Service (USPS) carrier van, overturning it and ejecting the driver. The driver of the mail carrier van, an adult male, was transported to the hospital with life-threatening injuries. Two juveniles were also struck by the SUV and suffered minor injuries. They drove themselves to the hospital for treatment.

At this time, the female adult driver of the SUV has been charged with reckless driving, per Division policy, and was released on a summons. She is scheduled to appear in court on her summons in the next week and a half. The Henrico Police Crash Team will collaborate with the Henrico County Commonwealth's Attorney's Office on any further charges that may be brought forth.

Henrico Police is working with the Henrico County Public School system regarding the assaults that occurred on school grounds this afternoon. Charges are currently pending.

This incident spanning across Highland Springs High School and into the nearby shopping center parking lot remains under investigation.





Henrico Police Investigates Break-ins at Buddhist Temples

(Henrico County, Va.) – Henrico Police is investigating several break-ins at Buddhist temples in Henrico County.

On Monday, October 30, 2023, at approximately 1:20 p.m., Henrico Police responded to the 2200 block of Mountain Road for a reported breaking and entering. Once on scene, officers spoke with the complainant who stated three men kicked in the back door to the temple, before fleeing the property. Nothing was reported as stolen during this incident. In January 2023, Henrico Police responded to this same location for a burglary.

Meanwhile, at approximately 6:38 p.m. that same day (10/30), Henrico Police responded to the 2400 block of Old Hanover Road for a reported breaking and entering. Once on scene, officers spoke with the complainant who said someone had kicked in the back door of the temple. Several items were taken along with cash at this location.

Currently, detectives are working to determine whether these two incidents are connected.

Unfortunately, break-ins at Buddhist temples are trending across the United States. The Henrico County Police Division has met with officials within the temples to provide tips on how to best prevent these types of incidents. Those safety tips include:

- Walk around your home/business/place of worship and look for any weaknesses. These could include unlocked windows or doors, poor lighting, overgrown shrubbery providing hiding spots, and so forth.
 - Make sure all doors and windows are secured when the building is not in active use.
- Invest in a camera system, and make sure it is turned on and functioning properly and captures all areas around your home/business/place of worship as well as activity in the street in front of the property.
- Do not leave large amounts of cash, jewelry, or anything of great value in your home/business/place of worship unsecured.
 - For best safety practices, refrain from keeping any cash within a place of worship.
- Be vigilant, look for and report any suspicious activity.

Vào khoảng 1 giờ 20 chiều Thứ Hai, ngày 30 tháng 10 năm 2023, Cảnh Sát Henrico đã đến khu 2200 trên Đường Mountain để báo cáo về một vụ phá hoại và đột nhập. Khi đến hiện trường, các sĩ quan đã nói chuyện với người khiếu nại, người này cho biết có ba người đàn ông đã đá vào cửa sau của ngôi Chùa trước khi bỏ trốn khỏi nơi đó. Trong khi đó, vào khoảng 6 giờ 38 chiều cùng ngày (30/10), Cảnh Sát Henrico đã đến khu vực số 2400 trên Đường Old Hanover để xử lý một vụ phá hoại và đột nhập. Khi đến hiện trường, cảnh sát đã nói chuyện với người khiếu nại, người này cho biết ai đó đã đá vào cửa sau của ngôi chùa. Một số đồ đạc đã được lấy cùng với tiền mặt tại địa điểm này.

Hiện tại, các thám tử đang làm việc để xác định xem hai vụ việc này có liên quan với nhau hay không.

Henrico Police Investigate Cliffbrook Lane Shooting

(Henrico County, Va.) – Henrico Police is investigating a double shooting that occurred in Henrico's central patrol area.

On Monday, November 6, 2023, at approximately 7:01 p.m., Henrico Police was dispatched to the 1800 block of Cliffbrook Lane for a reported shooting. Once on scene, officers located a juvenile male, 17 years of age, and an adult male with apparent gunshot wounds to the legs.

Officers immediately started life-saving measures until EMS personnel arrived on scene. Both victims were transported to an area hospital with life-threatening injuries where they continue to receive treatment.

The preliminary investigation shows the victims were shot inside an apartment. Two males believed to be involved in the shooting were detained for questioning. One of them was arrested on unrelated charges of:

- Possession of a Firearm with a Schedule I or II Drug
- Carrying a Concealed Weapon
- Possession of a Schedule I or II Drug

WATCH COMMANDER RELEASE 11/6:

(Henrico County, Va.) – At 1900 hours, Henrico Police officers were dispatched to the 1800 block of Cliffbrook Lane for a shooting call for service. Two male victims were found in the parking lot suffering from multiple gunshot wounds that are considered life-threatening. One victim is a juvenile and one victim is an adult. Both victims were quickly transported to area hospitals by Henrico Fire. Two individuals believed to involved were detained. The Henrico County Police Criminal Investigative Section is on scene and actively investigating the incident. There is no active threat to the community at this time.

Henrico Police Conducts Domestic Violence Offender Roundup

(Henrico County, Va.) – During the month of October, the Henrico County Police Division focused its efforts on rounding up offenders who have active warrants tied to domestic violence.

Domestic violence affects everyone – family, friends, co-workers and others in the community. Henrico Police continues to raise awareness about this nationwide issue not only in October, which is Domestic Violence Awareness month, but year-round.

During a multi-day operation, Henrico Police arrested 12 individuals who were wanted on outstanding domestic violence-related warrants. Nineteen total warrants were served which included:

- Strangulation
- Domestic Assault
- Violation of a Protective Order

Among the warrants served, the oldest was from May 2022.

"While the Henrico County Police Division actively works to take wanted individuals into custody yearround, this specific roundup rendered positive results," said **Henrico County Police Division spokesperson Lt. Amy Kelley**. "Patrol officers and specialized units within the Division located several offenders and gathered further intelligence on other wanted violent domestic offenders."

Currently, Henrico Police asks any community members with active warrants tied to domestic violence, to turn themselves in. If you know of someone with an active warrant, please contact Crime Stoppers at (804) 780-1000.

Knowing the signs of abuse is vital to mitigate domestic violence in Henrico County. Some of those signs include:

- Possessiveness
- Verbal abuse
- Forced sex or disregard of their partner's unwillingness to have sex
- Control of another person what they wear, their finances, interactions with others, etc.



Three Men Charged in August Hillbrook Ave Homicide

Update 1:

(Henrico County, Va.) – Henrico Police has identified three suspects in connection to an August 2023 homicide.

On Sunday, August 20, 2023, Henrico Police responded to the intersection of Emporia Street and Hillbrook Avenue for a reported suspicious situation. Once on scene, officers located an adult male, identified as **Earl Young Jr., 44, of Henrico**, with apparent gunshot wounds. He was pronounced deceased at the scene.

During the course of the investigation, suspects were developed in connection to the case.

On November 13, 2023, a Henrico Grand Jury issued indictments against:

- Kevonte Jackson, 22, of Richmond
- Jackee Lane, 18, of Richmond
- Amar Lewis, 18, of Henrico

At the time of these indictments, both Mr. Jackson and Mr. Lane were incarcerated in area jails. On Wednesday, November 15, 2023, Henrico Police took Mr. Lewis into custody off N. Laburnum Avenue without incident.

Arrest of Human Trafficker Leads to 18 Year Prison Sentence

(Henrico County, Va.) – Due to efforts by Henrico Police VICE detectives, in collaboration with the Henrico County Commonwealth's Attorney's Office, a North Carolina man will spend 18 years in prison for human trafficking.

On Wednesday, December 13, 2023, **Demontray Shadrell Bowman, 41**, was sentenced to 58 years in prison, with 40 years suspended.

Originally, Mr. Bowman was charged with 32 separate offenses but ultimately pleaded guilty to four counts of Commercial Sex Trafficking and four counts of Pandering.

"This guilty plea was the result of exhaustive work by VICE detectives and Assistant Commonwealth's Attorney Terrica Taylor, who poured through over 100,000 digital images, positively identified multiple victims of Bowman and secured the cooperation of several witnesses to testify against Mr. Bowman," said **a Sergeant who oversees the VICE unit**. Due to this line of work, we have refrained from identifying the sergeant.

This case stems from a March 2022 call for service in the 5300 block of Airport Square Lane where an adult woman contacted Henrico Police out of concern for her safety. The nearly two-year investigation shows Mr. Bowman had a widespread human trafficking operation stretching along the East Coast, from New York to Florida, stopping in most major cities along the I-95 corridor.

The Henrico County Police Division is committed to apprehending offenders who target individuals for sex and capital gain. The Division will continue to collaborate with the Commonwealth's Attorney's Office to ensure these offenders are taken off the street and the survivors of these crimes get the resources they need.

Henrico Man Sentenced to Life + 60 Years in Prison for Forcible Sodomy

(Henrico County, Va.) – A Henrico County man will spend life in prison after pleading guilty to charges of forcible sodomy.

On Thursday, December 14, 2023, **Scott Buchanon Fitzhugh**, **65**, **of Glen Allen**, was sentenced to Life plus 60 years in prison. In May 2023, a Henrico County Grand Jury indicted Mr. Fitzhugh on three counts of forcible sodomy.

This outcome was the result of a multi-agency effort to include the Henrico County Police Division, Henrico County Mental Health & Developmental Services, the Henrico County Commonwealth's Attorney's Office, the FBI Child Exploitation Task Force and state resources.

This case stems from a December 2022 call to Henrico Police from an area non-profit which reported concerns that had been disclosed to them about sexual actions Mr. Fitzhugh had taken with children. The Henrico County Police Division's Special Victims Unit was contacted and immediately started an investigation into this incident.

"Cases involving children are always difficult to comprehend and emotionally demanding to all involved," said **Henrico Police Detective L. Coover**. "A vast amount of evidence was collected in this case to include hundreds of images of child sexual abuse material that was in Mr. Fitzhugh's possession. The collaborative work by multiple agencies on this case shows the determination we have to ensuring all Henrico County residents, regardless of age, remain safe wherever they may be."

"We are grateful for the local, state, and federal partnerships we have, and we could not have put on such an airtight case without each member of the team working so well together," said **Henrico County Assistant Commonwealth's Attorney Alison Linas**. "Thanks to everyone's hard work, a very very bad man will never again walk free to harm children."

HCPD Officer-Involved Investigations Team Reviewing Officer-Involved Shooting

UPDATE 2:

(Henrico County, Va.) – Henrico Police continue to gather information about the events that occurred during two separate shootings in Highland Springs Friday morning.

The preliminary investigation shows while officers were enroute to the domestic call for service in the 100 block of Quinby Court, there was a physical struggle between an adult male and female where a firearm discharged. Once on scene, officers located the adult male who stated the female victim left the apartment after she was shot, heading to the 600 block of Shawn Court. Police detained the adult male for questioning. Based on information gathered about this incident, the adult male has not been charged at this time.

Officers then responded to the 600 block of Shawn Court to check on the shooting victim, where two officers discharged their firearms. At some point while at this location, one officer sustained a minor injury to the hand and was treated; no officers were shot.

The shooting victim from Quinby Court, later located in the 600 block of Shawn Court, sustained serious but non-life-threatening injuries. She was transported to an area hospital for treatment and has since been released. Currently, detectives do *not* believe the victim was injured during the officer-involved shooting on Shawn Court.

The adult male who was detained for questioning from the Shawn Court location has since been released and has not been charged at this time.

Per Division protocol, the Officer-Involved Investigations Team (OIIT), which investigates all officerinvolved shootings, will conduct a thorough internal investigation into this incident. The two officers involved will be placed on an administrative assignment pending the outcome of the internal investigation.

UPDATE 1:

(Henrico County, Va.) – Henrico Police continues to investigate the two separate shootings that occurred inside the Cedarwood Manor Apartment complex this morning.

On Friday, December 29, 2023, at approximately 3:38 a.m., Henrico Police responded to the 100 block of Quinby Court for a domestic call for service. As officers were enroute, information was received about a possible shooting at that location. Once on scene, officers located an adult male who stated the victim, an adult female, left the apartment after she was shot. Police detained the adult male from this scene.

Officers were advised the victim had relocated to the 600 block of Shawn Court. While responding to that location, officers were involved in a shooting. At this time, detectives within the Criminal Investigations Section (CIS) are working to determine what specifically unfolded at this location and have detained an adult male. One officer sustained a minor injury to the hand and was treated on scene.

The shooting victim from Quinby Court, who was later located in the 600 block of Shawn Court, was transported to an area hospital with serious, non-life-threatening injuries and has since been released.

There is currently no threat to the public, but the overall incident remains an active investigation with multiple investigative components involved. Due to the multiple incident locations, detectives are working as thoroughly as possible to determine the events of this morning. Specific details about these incidents will be released when they are available.

Per Division protocol, the Officer-Involved Investigations Team (OIIT), which investigates all officerinvolved shootings, has begun its investigation. The officers involved will be placed on an administrative assignment pending the outcome of the investigation.
