## Nine Men Arrested During Two-Day VICE Operation

(Henrico County, Va.) – On August 10-11, 2022, the Henrico County Police Vice Investigations Team conducted an operation targeting individuals who solicit juveniles online for sex. A total of nine local offenders were arrested during this operation.

These individuals solicited minors online for sexual services then attempted to meet up with the juveniles at an undisclosed location in Henrico County, however, were instead met by Henrico Police. Of the nine individuals contacted during this operation, eight showed up in person.

The success of this operation is due to the team effort by many units within the Division over the two-day period.

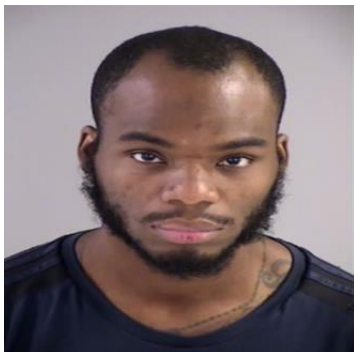
