#### PUBLIC COMMENT

Mr. Stewart Huffer a voter in the Brookland district addressed the Electoral Board on the issue of curbside voting. He offered suggestions to raise awareness and remove barriers of the curbside voting process such as PSA's, notices in utility billings, television/radio stations and newspaper advertisements.

Mr. Bryant thanked Mr. Huffer for his suggestions. Mr. Bryant indicated the Electoral Board will continue to seek cost effective and efficient ways to advertise curbside voting and that it is an ongoing priority of the Board. Mr. Shippee added that the infrastructure at each precinct is different. Engaging party representatives may be helpful in getting the word out that voting curbside is an option. Mrs. Woodson offered that the training of pollworkers will continue to stress the availability of curbside voting at all precincts in Henrico County. She added that in the November General Election student pages are available to assist with this effort.
