Provisional Ballots from, November 8, 2016, Presidential Election

The Registrar's office researched 1126 provisional ballots, from the November 14, 2016, Presidential Election. Mr. Coakley asked the board to accept the recommendations for:

- **Counting 563 Qualified Provisional ballots**
 - 4th Congressional District -145 ballots
 - 7th Congressional district- 418 ballots
- **Not counting 563 Not Qualified Provisional ballots**
 - 4th Congressional District-173 ballots
 - 7th Congressional District-390 ballots

On motion of Alice Creighton, and seconded by Cathy Woodson and by unanimous vote, the board has accepted the recommendation, of the General Registrar and staff for counting the 563 provisional ballots, which qualified and 563 provisional ballots, which did not qualify.
