Call to Order

The meeting was called to order by the Chair, at 1:30 p.m.

Bonnie Brae Church of Christ (Glenside Precinct) and Dumbarton Library (Greendale Precinct)

The Registrar's office received a letter from Bonnie Brae Church of Christ stating they're no longer act as a Henrico County precinct. The Electoral Board hereby moved that the Bonnie Brae (Glenside Precinct) be merged with the Johnson Precinct with voting to occur at Johnson Elementary School. The Registrar, Mr. Coakley, will take all appropriate and necessary actions to implement the precinct change.

In addition, the name of the Greendale Precinct (Dumbarton Library) will change from Dumbarton Library to Recreation & Parks Main Office. This change will occur because the building no longer serves as a library and serves as the main office for the Henrico Division of Recreation & Parks.

These precinct changes are pending the Board of Supervisors and Department of Justice approval. The Electoral Board plans to present the information per the Board of Supervisors' schedule.

On motion of Mrs. Woodson and seconded by Mrs. Creighton and subject to the approval of the Henrico County Board of Supervisors to change the following precincts:

- Glenside Precinct from Bonnie Brae Church of Christ, 7610 Staples Mill Road, Henrico, Va 23228 to Johnson Precinct, Johnson Elementary School, 5600 Bethlehem Road, Va 23230
- Greendale Precinct from Dumbarton Library, 6800 Staples Mill Road, Henrico, Va 23228 name to Recreation & Parks Main Office Precinct.
