**Call to Order**

**Provisional Ballots: November 8, 2022, General Election**

The Registrar's office researched 1,362 Provisional ballots, from the November 8, 2022, General Election. Mr. Coakley asked the electoral board to accept the recommendations for 954 to count and 408 rejected ballots.

• **Counting 954 Qualified Provisional ballots**

1<sup>st</sup> Congressional District – 604 provisional ballots  
4<sup>th</sup> Congressional district – 350 provisional ballots

• **Not counting 408 Not Qualified Provisional ballots**

1<sup>st</sup> Congressional District- 214 provisional ballots  
4<sup>th</sup> Congressional District- 194 provisional ballots

On motion by Linwood Cobb, III and seconded by Cathy Woodson and by unanimous vote, the board has accepted the recommendation, of the General Registrar and staff for counting the 954 provisional ballots which qualified and rejecting 408 provisional ballots, which did not qualify.
