On a motion made by Mrs. Woodson, seconded by Mr. Shippee, the Board voted to place secure ballot boxes, subject to availability of ballot boxes from the vendor, for the primary scheduled on June 8, 2021. The ballot boxes are to be placed at proposed locations (Henrico Public libraries); to be located inside the library and secured inside the library, installed in sight of librarian staff and the library hours to conform to the Henrico Registrar's office during the voting period.
