Call to Order

The meeting was called to order by the Vice-Chair, at 10:47 a.m.

Public Comments

Mrs. Boyle asked when the Republican party has a convention not a primary election and the Democratic party has a primary election- why are only the democratic election officials chosen to conduct the primary election? Mr. Shippee stated the election of the party (Democratic) is to nominate their candidate. Mr. Coakley stated the Election Officials are not registered by party, however, when giving the oath of office they agree to provide coverage of the primary election for all parties.

Good of the order

Mr. Shippee discussed the Legislative bills that may affect the Registrar's office:

- State Board of Elections expansion from five to eight members
- Mail-in Absentee ballots witness requirements

Mr. Shippee asked for a recap on Redistricting from the last meeting held on January 28th, 2022. Mr. Coakley gave the recap on Redistricting, and he will also attend a virtual meeting with the State Board of Elections at 1:00 p.m. regarding the two split-precincts: 105-Hermitage and 214-Hungary.

Mr. Coakley stated the electoral board will receive a summons delivered by the sheriff deputies regarding the Henrico Bond Referendums.

Mrs. Boyle stated she hasn't heard any update from the Registrar's office regarding election reporting by precincts of Absentee ballots. Mr. Shippee says this is still in discussion and there are meetings held today regarding absentee ballots sorted and reported by precincts.

Mr. Coakley asked Mr. Shippee about the Risk Limiting Audit for the upcoming elections. Mr. Shippee stated he spoke about the RLA at the hearings and the audit will continue for the localities. Mrs. Boyle asked if the Registrar's office would request assistance from the State or prefer to proceed on their own. Mr. Coakley stated the best

practices is guidance from the State. Mrs. Woodson thanked Mrs. Boyle for her question and stated the localities will work to meet code the of VA requirements.

Close session to discuss election security
