## Project Description

This project consists of 2 miles of a 12-ft wide multi-use trail connecting Spring Park to Hilliard Road. Construction will include several pedestrian bridges spanning the Upham Brook tributary. The trail will follow the Upham Brook Sanitary Sewer project alignment.

The County intends on applying for a federal Transportation Alternatives (TA) grant to fund the construction of the trail and welcomes comments from the community on this proposed trail.

## Environmental Review

Henrico County will review the social, economic, and environmental impacts of the proposed project on the local community and surrounding area. During construction, all reasonable efforts will be made to protect the environment with respect to dust control, siltation and erosion.

Construction will conform to all County, state, and federal standards and regulations with respect to protecting the environment.

## Right-of-Way/Easements

Property owners will be informed of the exact location of the easements during the right-of-way acquisition process and prior to construction

### Location:

From Spring Park to Hilliard Road

**Length:** 2 miles (approximate)

To provide a safe and accessible trail to be used for commuting and recreational activities. The trail is intended for pedestrians, cyclists, and other forms of non-motorized transportation.
