



Henrico County Recreation and Parks 50+ Photography Contest



Theme: "Recreation and Parks in Henrico County"

- Each photograph must be taken in Henrico County with the location clearly stated on the contest entry form.

Format

All entries must be submitted unframed as an 8" x 10" printed photograph.

- Photographs may be color or black and white.

Who May Enter

- Any Henrico County resident who is 50+ and who is not a professional photographer may enter.

How to Enter

- Each submitted photograph must be a single work of original material taken by the contest entrant.
- Individuals may submit up to 3 photographs.
- Each entry consists of one entry form and one photograph.
- Entries must be received or postmarked between March 2 and March 27, 2015.
- Photographs may be submitted in person or by mail to one of the following locations:

- Mail-in entries must be postmarked by March 27, 2015 and addressed to "Photo Contest Administrator."
- Entries delivered in person must be delivered Monday-Friday, 8:00a.m.-4:30 p.m.
- If the photograph entry includes other people, you must be prepared to provide a signed written personal release from all persons who appear in the photograph submitted, authorizing the use and display of the photograph by Henrico County.

Contest Awards

- Ribbons will be awarded as follows:
 - (1) First Place
 - (1) Second Place
 - (1) Third Place
 - (5) Honorable Mentions
- The photograph awarded First Place will be featured in a future Recreation and Parks Program Guide. The contest First Place Winner should be prepared to submit the winning photograph in digital form for publication.

Judging

- Entries will be judged on the basis of creativity, photographic quality and effectiveness in expressing the contest theme.
- Decisions of the Judges are final and binding.

Entrant Releases

- If the photograph contains any material or elements that are not owned by the entrant and/or which are subject to the rights of third parties, and/or if any persons appear in the photograph, the entrant is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph by Henrico County.
- If any person appearing in any photograph is under the age of 18, the signature of a parent or legal guardian is required on each release.
- By participating, entrants grant Henrico County permission to use and display the photographs entered.

Limitation of Liability

- By participating, entrants agree to release, discharge and hold harmless Henrico County and its representatives from any claims, losses, and damages arising out of their participation in this contest or any contest-related activities.
