 caused to be corrected, to the satisfaction of the Beneficiary, damage or
 deterioration on the street, road and/or drainage improvements described above as
 required by Henrico County at the above described location;
- A certified statement, signed by the Henrico County Director of Public Works or his
 designee, stating that the drawing is for the explicit purpose of providing for the
 repair and/or replacement of the above described improvements as required by
 Henrico County at the above described location; and,

We hereby engage with drawers, endorsers and bona fide holders that all drafts drawn in compliance with the terms of this letter of credit shall be duly honored upon presentation and delivery of such documents.

This irrevocable letter of credit shall remain in full force and effect for a period of one (1) year from the date when the above described improvements are fully completed and accepted by the Beneficiary.

This letter of credit may be terminated by the Beneficiary giving a written release to the Applicant and to the Bank stating that the Applicant has furnished the Beneficiary with an acceptable substitute financial guarantee in an amount sufficient for and conditioned upon the repair and/or replacement of the improvements.

This letter of credit is not assignable by the Bank, Beneficiary or Applicant. The Bank, Beneficiary or Applicant further hereby agree that this letter of credit shall be subject to the following provisions:

 Funds available under this letter of credit shall be paid to the Beneficiary in such amounts and at such times as determined by the Director of Public Works or his designee, in his sole discretion, provided that the amount drawn shall not exceed the face amount of this letter of credit. The Bank shall have no right, duty, obligation, or responsibility to evaluate the performance or nonperformance of any underlying obligations, contractual or otherwise, between the Applicant and the Beneficiary or between the Applicant and any third party;

- 2. The Bank hereby agrees that no change, extension of time, alteration or addition to the repair or replacement work to be performed, or the plans or specifications relating to the same, shall in any way affect the Bank's obligation under this letter of credit. The Bank hereby waives notice of any such change, extension of time, alteration or addition on the understanding that no such change, extension of time, alteration or addition shall increase the amount of the Bank's obligation under this letter of credit; and,
- 3. Approval of this letter of credit by the Beneficiary shall be deemed acceptance thereof without further notice either to the Bank or to the Applicant.

The Bank hereby undertakes to honor all drafts presented to the Bank by the Beneficiary drawn under and in compliance with the terms of this letter of credit.

This irrevocable letter of credit shall be construed in accordance with the "Uniform Customs and Practices for Commercial Documentary credits" promulgated by the International Chamber of Commerce (International Chamber of Commerce Brochure No. 500, 1993 revision) and the provisions of the Uniform Commercial Code - Letters of Credit - Title 8.5 of the Code of Virginia, 1950, as amended.
