Summary of Actions Taken by the Board on October 25, 1995

The invocation was given by Reverend Morgan S. Smart, Retired Methodist Minister.

The minutes from the October 11, 1995 Regular and Special Meetings of the Board of Supervisors meeting were approved.

MANAGER'S COMMENTS

The Virginia Recreation and Parks Society has awarded the Division of Recreation and Parks a 1995 Presidential Award. This is the highest honor that the Society's President can bestow on an individual or organization and was presented for the Division's support, dedication, and hard work in preparation for the Society's 1995 conference held in Henrico County September 17 - 19, 1995.

As of October 24, 1995 Henrico County employees had raised \$92,100 for the United Way Campaign, 4.7 percent over the 1995 goal and a 19.9 percent increase over 1994 giving. This year an additional 114 County employees contributed to the Campaign, which was chaired by County Fire Chief Mark Light.

Last month, the County of Henrico and the State Fair of Virginia joined forces to commemorate Pocahontas' 400th birthday by constructing an authentic replica of a 17th century Powhatan Village which used Native Americans to portray Pocahontas and other tribal members. Powhatan Village received the Director's Choice Award for the best exhibit at the 1995 State Fair. Vice President and General Manager for the State Fair of Virginia, Keith Hessey, presented the award to David A. Kaechele, Chairman, and also presented certificates of appreciation to the following County officials for their roles in planning and promoting this event: John A.
