

# Supervisors Agend-O-Gram

Summary of Actions Taken by the Board on January 28, 1998

The invocation was given by Rev. William S. Ferguson, Visitation Minister, Westhampton United Methodist Church.

The minutes of the January 14, 1998 Regular Meeting were approved.

#### **MANAGER'S COMMENTS**

The National Juvenile Detention Association has once again sponsored the "Bob Rader Line Staff Worker of the Year" award and the "Bob Rader Detention Services Worker of the Year" award. Through a vote of their peers at the Juvenile Detention Home, Cynthia Thompson was selected as the outstanding child care worker and Carl Streat, a senior cook, was selected as the outstanding detention services worker. Ms. Thompson was one of 23 people and Mr. Streat was one of 22 people honored nationally by the Association.
