### **MANAGER'S COMMENTS**

On December 9, 1998, Kenneth W. Limerick, a Case Manager with Henrico Area Mental Health and Retardation Services, received the 1998 Associate Member of the Year Award from the Richmond Apartment Management Association (RAMA). The award was in recognition of his contributions to the multi-housing industry, which include success in using Virginia Housing Development Authority (VHDA) "Section 8" certificates to locate safe and affordable housing in Henrico County for disabled citizens, and his loyalty to RAMA and its membership.

The National Juvenile Detention Association once again sponsored the "Bob Rader Staff Worker of the Year" award and the "Bob Rader Detention Services Worker of the Year" award. At the Juvenile Detention Home Christmas Party on December 18, 1998, George W. Spinner was selected as the outstanding Child Care Worker and N. Dianne Maness, Administrative Secretary, was selected as the outstanding detention services worker. Both were one of only twenty persons in each category to receive this national honor.

At the State and Local Government Affairs Awards Breakfast held by the National Association of Home Builders on January 15, 1999, Deputy County Manager for Special Services, Angela Harper, was awarded the Association's Local Official of the Year award for the Northeast/Mid-Atlantic Region. She was the only official receiving an award from the region and one of only five local officials recognized this year. Mrs. Harper was nominated for the award because of her long time dedication to working with the Home Builders Association of Richmond as a professional planner with the County and her recent facilitation of the Development Timetables Project as Deputy County Manager.

Virgil R. Hazelett, P.E., County Manager, advised the public that Michael Lovern, Sr. had requested once again to address the Board concerning his ongoing litigation with the School Board and allegations of misuse of County funds for legal representation of County officials. Mr. Hazelett offered background information on Mr. Lovern and suggested that he should direct his complaints in the future to the Internal Revenue Service and School Board.
