# Summary of Actions Taken by the Board on September 28, 1999

The invocation was given by Reverend Keith Ritchie, St. Andrew's United Methodist Church.

The minutes of the September 14, 1999 Regular and Special Meetings were approved.

## **PUBLIC COMMENTS**

Tom Obenschain, a resident of the Fairfield District, expressed support for Mr. Thornton's efforts to establish a new civic center in eastern Henrico County.

Rev. Carlton W. Robb, also a resident of the Fairfield District, expressed concerns about the extended power outages experienced by households in Hechler Village after major storms.

#### **BOARD OF SUPERVISORS' COMMENTS**

Mr. Donati noted that he had asked Mr. Hazelett to schedule a work session with the Board of Supervisors and representatives of Virginia Power to discuss Virginia Power's recent problems in restoring electric service to certain areas of Henrico County. He also thanked Mr. Hazelett and the personnel who operated the County's Emergency Command Center for their responsiveness during Hurricane Floyd.

Mr. Glover asked Mr. Hazelett to make inquiries of public officials in Franklin, Virginia and surrounding areas to see whether Henrico County might provide further public safety assistance in the aftermath of Hurricane Floyd and the resulting floods.

Mrs. O'Bannon thanked the Department of Public Works for collecting storm debris in County neighborhoods without charge to County citizens and referenced the many favorable calls she had received from constituents about this special service offered in response to damage caused by Hurricane Floyd.
