Summary of Actions Taken by the Board on October 26, 1999

The invocation was given by Dr. Benjamin W. Robertson, Cedar Street Memorial Baptist.

The minutes of the October 12, 1999 Regular and Special Meetings were approved.

MANAGER'S COMMENTS

The City of Chesapeake's Budget Department has again surveyed the level of major revenue sources in thirteen major Virginia cities and counties and has published the results for Fiscal Year 1999-00 in a special document. The Chesapeake study indicates that among the localities surveyed, Henrico has the lowest overall taxes and fees while providing a high level of public services. This factor is a positive for the County, particularly when recruiting economic development prospects in competition with other localities.

Edward N. Lambani, Chief Director for Legal Services with the Independent Electoral Commission in Pretoria, South Africa, reported to the County's Office of General Registrar on October 14, 1999 for a three-week internship. An attorney with several advanced degrees in law and Advocate of the High Court of South Africa since 1997, Mr. Lambani is one of twelve South African representatives currently visiting the United States to study its electoral process. Mr. Lambani, who was recognized by Mr. Hazelett at the Board meeting along with Bebe W. West, Vice-Chairman of the County's Electoral Board, briefly addressed the Board concerning his visit.

BOARD OF SUPERVISORS' COMMENTS

Mrs. O'Bannon announced that Douglas S. Freeman High School was one of 17 public and private middle and high schools throughout the state that had participated earlier in the day at Charlottesville High School in the largest Internet election in the nation's history. Students voted on-line using a "cyber ballot" that was specifically tailored to each student's individual voting precinct. The mock election was part of the Youth Leadership Initiative (YLI) launched this school year as a pilot project in Charlottesville and the counties of Henrico, Albemarle, Page, and Shenandoah. YLI is the signature program at the University of Virginia Center for Governmental Studies, founded by U.Va. Professor Larry J. Sabato in 1998 as a non-partisan public interest center dedicated to restoring the health of America system of representative self-government. To conduct the mock election, the Center for Governmental Studies partnered with VoteHere.net, an internet balloting company based in Kirkland, Washington.

Mrs. O'Bannon also recognized a group of students from Douglas Freeman High School on assignment from Mrs. Susan Jones' government class.

Mr. Thornton recognized Deandre Alexander, a Scout with Webelos Pack 508 sponsored by Chamberlayne Baptist Church. He was in attendance with Den Leader Ancher Madison.
