Summary of Actions Taken by the Board on September 12, 2000

The invocation was given by Reverend J. Leroy Davis, Pastor, Goodwill Baptist Church.

The minutes of the August 8, 2000 Regular and Special Meetings were approved.

MANAGER'S COMMENTS

David B. Gehm, Treasury Division Director for the Department of Finance, received the professional designation of Master Government Deputy Treasurer from the University of Virginia's Weldon Cooper Center for Public Service and Continuing Education on August 14, 2000. He was in the first class to earn this designation, which requires the candidate to pass a comprehensive exam in four core courses in his field and complete a minimum of ten hours a year in continuing education credits over a two-year period.

Varina District Supervisor James B. Donati, Jr. was appointed last month by Virginia Senate Majority Leader Walter A. Stosch to a four-year term on the Commonwealth's seven-member Small Business Environmental Compliance Advisory Board. Mr. Donati is one of four members of the Advisory Board representing owners of small business stationary sources and one of only two members appointed by the Virginia State Senate. The Advisory Board's duties include issuing opinions on the effectiveness of the Virginia Department of Environmental Quality's Small Business Assistance Program, reporting to the Virginia General Assembly and United States Environmental Protection Agency concerning the program's compliance with federal requirements, and helping ensure that small business stationary sources understand their rights and responsibilities under federal law.
