Summary of Actions Taken by the Board on February 12, 2002

Reverend Dr. Thomas E. Miller, Jr., Interim Pastor, Skipwith Baptist Church, provided the invocation.

The minutes of the January 22, 2002 Regular and Special Meetings and October 19, 2001 Special Meeting were approved.

MANAGER'S COMMENTS

Mr. Hazelett thanked the members of the Board of Supervisors for their cards and telephone calls during his recovery from major surgery. He also expressed his appreciation to Robert K. Pinkerton for serving as Acting County Manager and to his immediate staff for filling in during his absence.

For the thirteenth consecutive year, the County's Department of Finance has received the Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA). This award was made after Henrico's budget document was reviewed and rated favorably by an expert panel of independent budget professionals and reflects the commitment of many individuals to meeting the highest standards of governmental budgeting.
