Summary of Actions Taken by the Board on October 8, 2002

Reverend Joseph T. Driver, Gospel Jail Ministries, provided the invocation.

The minutes of the September 24, 2002 Regular and Special Meetings were approved.

MANAGER'S COMMENTS

Henrico County's Permit Center recently won a Governor's Technology Award in recognition of the Center's innovative use of information technology and staffing to enhance services for area residents. Frederick F. Overmann III, the County's Director of Community Development, accepted the Silver Award for Local Governments at the 2002 Governor's Technology Awards Banquet held in Lexington at Virginia Military Institute during the Fourth Annual Commonwealth of Virginia Information Technology Symposium. Virginia's Secretary of Technology, George Newstrom, presented this award, which was one of only 16 conferred this year statewide and one of only two granted in the local government category.

PUBLIC COMMENTS

Carolyn L. Davis, a resident of the Fairfield District, thanked Mr. Thornton for expediting the repaving of Harvie Road and for initiating a study to lower its speed limit. She also requested the County's assistance in reducing truck traffic on Harvie Road.

Gatewood H. Stoneman, a resident of the Varina District, reminded the Board that 4-H Week was being recognized this year from October 6 to 13 and noted that Virginia 4-H was celebrating its 100th anniversary. She thanked the Board for its past support of 4-H programs.
