## Summary of Actions Taken by the Board on February 25, 2003

Reverend Angelo Chatmon, Pastor, Pilgrim Journey Baptist Church, provided the invocation.

The minutes of the February 11, 2003 Regular and Special Meetings were approved.

### **MANAGER'S COMMENTS**

For the seventeenth consecutive year, the Henrico County Department of Finance's Office of Management and Budget has prepared a financial trends report prior to examination of the operating budget for the subsequent fiscal year. The *Financial Trends Monitoring System* document analyzes existing economic conditions in Henrico County through the use of 28 financial indicators and is updated annually to provide the Board with historical information over an 11-year period.

Sheriff Michael Wade recently celebrated the birth of his first grandchild, Michael Joseph Wood.

The County's Department of Public Works spent \$950,000 on snow removal during the period of February 15 - 21, 2003, including \$250,000 for contract services and \$240,000 for chemicals and materials. The total cost to the County for snow removal for the current winter season is approximately \$2 million. Excessive water and low temperatures have caused significant pavement failures and will result in higher than normal pavement repair costs.
