## Summary of Actions Taken by the Board on May 27, 2003

## **MANAGER'S COMMENTS**

Steven M. Lewis has been appointed Director of Information Technology for the County of Henrico, effective June 4, 2003. A graduate of West Virginia University, Mr. Lewis has over 30 years of experience in the fields of technology and communications and has served as the County's first Assistant Director of Information Technology since joining the organization in 1997. The Department of Information Technology comprises 84 employees, an \$11 million annual operating budget, and a multi-enterprise server computer center that operates around-the-clock, seven days a week and supports 33 major computer application areas, including electronic and voice mail systems. Mr. Lewis was one of several top candidates interviewed by a panel and was selected for the position from a group of approximately 50 applicants.

The more than \$5,200 raised by Henrico County employees in only a one-month period during the 2003 March of Dimes Campaign was the second highest amount collected among all Richmond area teams. The combined collections from the following team captains represented over 40% of the County's total contribution: Highest Overall - Stephen Saunders, Department of General Services, Facilities Management Division; Second Highest Overall - Lynnette McDowell, Division of Recreation and Parks; Third Highest Overall - Mary Davis, Department of Public Utilities; and Highest Per Employee Contribution - Gary Martin, Office of Internal Audit. Sandra Corcoran of the Department of General Services, who is new to the County organization, graciously volunteered to serve as this year's County government March of Dimes Coordinator. She and her departmental team captains were instrumental to the County's outstanding performance.
