# Summary of Actions Taken by the Board on September 9, 2003

Reverend Chester J. Smith, Pastor, Bethlehem Baptist Church, provided the invocation.

The minutes of the August 12, 2003 Regular and Special Meetings were approved.

# **MANAGER'S COMMENTS**

Judy A. Davis Poore, Auditor III in the County's Office of Internal Audit, recently passed the Certified Information Systems Auditor (CISA) examination given by the Information Systems Audit and Control Association. Since 1978, the CISA exam has measured excellence in the area of Information Systems auditing, control, and security while CISA has grown to be globally recognized and adopted worldwide as a symbol of achievement. Ms. Poore is also a Certified Public Accountant, Certified Internal Auditor, Certified Fraud Examiner, and Certified Government Auditing Professional.

The County's Office of Internal Audit hosted a Chinese delegation from the Hangzhou Municipal Government Bureau of Audit on September 9, 2003. As senior executives in charge of internal auditing in local government agencies, the 16 delegates from Hangzhou were interested in the mission and function of the County's Office of Internal Audit, the laws and regulations that relate to internal auditing, and an overview of continuing education in internal auditing in the County. Last year, a delegation from China's Hunan province visited with the County so Internal Audit staff. Mrs. O'Bannon once again provided greetings from the Board of Supervisors as well as introductory remarks.

On September 3, 2003, the Virginia Department of Corrections completed its three-year comprehensive audit at the County's Jail East facility, which found the Sheriff So Office in 100% compliance with all 118 standards. Major Doug Herbert manages the facility and Lt. Darlene Dailey was responsible for having the Standards Section compile the documentation. The Department of Corrections received no substantive complaints during interviews with inmates and employees and complimented Sheriff Mike Wade and his staff on their performance.

During the first weekend of September, the County's Department of Public Works, Divisions of Fire and Police, and volunteer rescue squads stepped up to the plate with professionalism and enthusiasm to provide traffic control and ensure public safety at the NASCAR race, Short Pump Town Center grand opening, and high school football games. In addition to working long hours at these events while maintaining routine services, County personnel responded to a ten-hour standoff that required extreme diligence and tenacity to resolve peacefully. Although County resources were stretched to the maximum, the County received many compliments on its efforts from event organizers, participants, and observers.

The County's Division of Fire, directed by Chief Ronald Mastin, was again granted accreditation status on August 21, 2003 at the semi-annual meeting of the Commission on Fire Accreditation International held in Dallas during the International Association of Fire Chief's Conference. When the Division was first accredited in 1998, it was the ninth fire service organization in the world and first within Virginia to achieve this status. Approximately 25 Division of Fire personnel led by Assistant Chief Nick Caputo worked on the current accreditation effort. Fire service personnel from Bellevue, Washington; Fulton County, Georgia; Toronto,

Ontario, Canada; Palm Beach County, Florida; and Calgary, Alberta, Canada performed the June 19, 2003 onsite validation and peer assessment review process.

Mr. Hazelett read a proclamation issued by President George W. Bush recognizing September 11, 2003 as Patriot Day. He noted that the County would follow the President's request to fly flags at half-staff and observe a moment of silence at 8:46 a.m. on Patriot Day "to honor the innocent victims who lost their lives a result of the terrorist attacks of September 11, 2001."

Curtis Cornell, a resident of the Brookland District, reiterated his dismay regarding the County's enforcement of the Building Maintenance Code, which resulted in the recent demolition of a house on his property.

Mr. Kaechele announced the publication of a new book on County Manager government in Henrico and recognized the book's author, Dr. Nelson Wikstrom of Virginia Commonwealth University, for his efforts in making this information available to County citizens and other interested persons.

Mr. Kaechele recognized David Klein from Boy Scout Troop 772, sponsored by Discovery United Methodist Church, who was observing the meeting.

Mr. Donati recognized Chris Snedden from Boy Scout Troop 522, sponsored by Sandston Presbyterian Church, who was observing the meeting.
