She also commented on the County's 399-year history of good decisions and the outstanding services provided to Henrico citizens within a low tax environment. Mrs. O'Bannon concluded by reciting the County's motto, "Proud of Our Progress, Excited About Our Future" within the context of the County's 400th commemoration year in 2011.
