MANAGER'S COMMENTS

At its annual spring conference held last month in Reston, Virginia, the Local Government Attorneys of Virginia (LGA) awarded the 2010 Cherin Award for an Outstanding Deputy or Assistant Local Government Attorney to Henrico Senior Assistant County Attorney Karen M. Adams. She is the third member of the County Attorney's to receive this award, following in the footsteps of her colleagues John Knight and Rhysa South.

Mr. Donati announced that the Henrico Division of Police won the Henrico County Cup in this year's Eastern Henrico Business Association golf tournament. He presented the trophy to Col. Henry W. Stanley, Jr., Chief of Police, who will proudly display the trophy in the Division offices.

PUBLIC HEARING ITEMS

107-10 Resolution – Signatory Authority – Purchase and Leaseback of Property – 8600-8604 Staples Mill Road - Brookland District. (Deferred from the April 27, 2010 meeting).

Mr. Glover noted that the Board had discussed this item earlier in the evening during a closed meeting. Mr. Hazelett explained to the public that this proposed acquisition of property was part of a master plan for the overall expansion of the County government complex. A juvenile courts facility will be located in this general area.

No one from the public spoke in opposition to this resolution.

On motion of Mr. Glover, seconded by Mr. Kaechele, and by unanimous vote, the Board approved this item – see attached resolution.

124-10 Resolution - Signatory Authority - Easement Agreement for Virginia Electric and Power Company - Tuckahoe District.

Jon Tracy, Director of Real Property, responded to a question from Mrs. O'Bannon.

No one from the public spoke in opposition to this resolution.

On motion of Mr. Kaechele, seconded by Mr. Thornton, and by unanimous vote, the Board approved this item – see attached resolution.

125-10 Resolution - Condemnation - Right-of-Way and Easements - North Gayton Road Extension Project - Raleigh R. Cook and Carolyn A. Cook - Three Chopt District.

> Mr. Tracy responded to a question from Mr. Kaechele relating to the number of parcels affected by this project for which the County has not yet reached agreement with the property owners.

Mr. Cook, the owner of the property addressed by this resolution, addressed the Board. He provided a timeline and overview of previous negotiations with the consultant of the County's contractor. He also expressed concerns regarding the difficulty he had encountered in getting answers to his questions about the County's need to acquire right-of-way and easements across his property. Mr. Cook also spoke to unresolved drainage issues pertaining to his property. He requested a 30-day deferral of this resolution pending answers to his questions.

Mr. Hazelett assured Mr. Cook that he will receive the information he has requested and that although the County will try every way possible to reach agreement with him the condemnation process needs to move ahead to avoid the potential of delaying the project. Mr. Cook expressed appreciation for the efforts of Jack Beirne with the County's Real Property Department and Donny Johnson with the County's Department of Public Works. In response to a statement made earlier by Mr. Cook, Mr. Glover suggested that the County consider providing Mr. Cook access to the rear of his property in exchange for the right-of-way and easements needed by the County for this project. Mr. Hazelett agreed to follow up on this offer by Mr. Cook as part of the County's negotiations with him. Mr. Cook responded to questions from Mr. Kaechele relating to the size and configuration of Mr. Cook's property and how a proposed permanent drainage easement will impact his property. Mrs. O'Bannon noted that she was impressed with Mr. Tracy and his staff for having resolved a number of condemnation cases.

On motion of Mr. Kaechele, seconded by Mr. Glover, and by unanimous vote, the Board approved this item – see attached resolution.

PUBLIC COMMENTS

William Spencer, a resident of the Three Chopt District, noted the passing of Walter Penny, Jr., a prominent local citizen who taught at Armstrong High School and other Richmond City public schools. Mr. Spencer also thanked the Board for not cutting County positions, commented favorably on pending changes at Virginia Randolph Community High School, and shared personal anecdotes.

Zandra Sharon, a resident of the Varina District, expressed concerns regarding the Division of Police's investigation of a missing person case involving her 20-year-old missing daughter, Arianna Davis. She thanked Mr. Thornton for telephone calls he made on her family's behalf to bring more attention to the case. Her pastor asked for directives from the County on how the family and community can become more involved in the case. Mr. Hazelett assured Ms. Sharon that Col. Stanley will be contacting her again to review the case and that the County will assist her in every way possible.

Vickie Beaty, a resident of the Three Chopt District, conveyed concerns relating to commercial construction activities at Ridge Shopping Center on the site of a former Hardee's restaurant, including the removal of a fence adjacent to her rear property line. She responded to questions from Mrs. O'Bannon and Mr. Kaechele. Mr. Hazelett advised Ms. Beaty that he will look into her concerns, including the timing of the installation of a new fence as a condition of the development.

Darryl Badley, a resident of the Three Chopt District and General Manager of the Virginia Hornets Minor League Football Team, provided information on his non-profit organization and introduced Brittany Rose, a Virginia Commonwealth University student and the owner of More Than Cheer, a private cheerleading instruction company. Mr. Badley thanked Henrico Sheriff Michael Wade for permitting Henrico Sheriff's Office deputies to participate in the Virginia Hornets 3rd Annual Charity Flag Football Game on May 29, 2010 at Highland Springs High School, which will benefit the Special Olympics Virginia Law Enforcement Torch Run. He also thanked the Board for giving non-profit organizations the opportunity to function in the County and serve the community.




- (2) The Board deems it necessary to enter upon the property and take possession of the Right-of-Way and Easements in order to construct the Project prior to the time in which a condemnation case can be filed and heard in accordance with the Code;
- (3) The County Manager shall send by certified mail a notice dated May 26, 2010, advising the Owners that the County intends to enter upon and take the Right-of-Way and Easements prior to the conclusion of condemnation proceedings, setting forth the compensation and damages offered by the County, and informing the Owners of the 30 days within which to contest the taking;
- (4) The Board finds a necessity exists to institute condemnation proceedings pursuant to the Code to acquire the Right-of-Way and Easements for the public use of constructing, operating, and maintaining the Project and to determine the amount of compensation and damages, if any, caused by the taking, possession and acquisition of the Right-of-Way and Easements;
- (5). After the 30-day period for the Owners to contest the taking has run, the County Attorney shall file in the Clerk's Office of the Circuit Court a certificate signed by the Chairman and Clerk of the Board in accordance with the Code and shall deposit with the Clerk the amount of the bona fide offer listed below that has not been accepted by the Owners:

RALEIGH R. COOK AND CAROLYN A. COOK AS TO 4900 POUNCEY TRACT ROAD - \$22,725

and,

(6) The Board authorizes and directs the County Manager to continue to seek a voluntary acquisition of the Right-of-Way and Easements, to take all steps necessary to acquire the Right-of-Way and Easements, and to enter on and take immediate possession of the required Right-of-Way and Easements.

Comments: The Real Property Department has been unsuccessful in negotiating a settlement for the acquisition of the Right-of-Way and Easements. Therefore, the Directors of Public Works and Real Property recommend approval of this Board paper, and the County Manager concurs.

WHEREAS, a review and evaluation of all bids received determined that Piedmont Construction Company is the lowest responsive and responsible bidder.


NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Henrico County:

1. The contract is awarded to Piedmont Construction Company, the lowest responsive and responsible bidder, in the amount of \$258,112.80, pursuant to Bid Request No. 10-8815-3CE, Addendum No.1, and the bid submitted by Piedmont Construction Company.

2. The County Manager and Clerk are authorized to execute the contract in a form approved by the County Attorney.

3. The County Manager, or the Director of General Services as his designee, is authorized to execute change orders within the scope of the project budget not to exceed 15% of the original contract amount.

Comment: Funding to support the contract is available within the Water and Sewer Enterprise Fund. The Directors of Public Utilities and General Services recommend approval of this Board paper, and the County Manager concurs.
