COUNTY OF HENRICO, VIRGINIA BOARD OF SUPERVISORS SPECIAL MEETING November 13, 2012

The Henrico County Board of Supervisors convened a special meeting on Tuesday, November 13, 2012, at 5:30 p.m., in the County Manager's Conference Room, Administration Building, Henrico County Government Center, Parham and Hungary Spring Roads, Henrico, Virginia.

Mr. Glover called the meeting to order at 5:36 p.m.

Mr. Hazelett noted that there was one item listed on the agenda, which would be discussed in closed meeting. At his request, the Board added a second item by waiver and agreed to move it to the front of the agenda.

2012 General Election Debriefing

Mr. Hazelett introduced this waiver item and recognized Mark Coakley, General Registrar, who read a prepared statement concerning the November 2012 General Election. Mr. Coakley pointed out that although many voters in Henrico County experienced long lines on Election Day, for which he apologized, all of the voting machines in the County were in use and long lines were commonly experienced by voters throughout the Commonwealth and the United States. He

acknowledged that responsibility for conducting the County's elections rests solely with the Electoral Board. Mr. Coakley further acknowledged that the Board of Supervisors has filly funded the County's Office of Voter Registration and Elections and has been supportive of the office's requests. He noted that only 24 of the 594 online Election Day complaints received by the Virginia State Board of Elections occurred in the County. Mr. Coakley distributed to the Board a spiral-bound booklet containing detailed official election results for Henrico as well as the location and incident type of the online complaints received by the Virginia State Board of Elections. He also distributed a color-coded map depicting the total number of presidential votes received by each candidate in each of the County's precincts.

Following his prepared statement, Mr. Coakley responded to questions and comments from the Board pertaining to the types and magnitude of complaints received from County voters, factors contributing to the long lines experienced by many County voters, the numbers of absentee and provisional ballots that were cast locally, power outages that occurred at the Math and Science Center and Glen Lea precincts, parking problems at the Glenside precinct, the closing times for individual County precincts, and the County's voter turnout. He expressed particular concem about the long wait some elderly voters experienced due to problems with curbside voting at certain precincts. Mr. Coakley offered several suggestions that may help reduce lines in the future for national elections where there is an especially heavy turnout, such as splitting precincts that have larger numbers of voters and increasing the number of electronic poll books at precincts. Other measures to address this problem, such as no-excuse early voting, would require changes to the Code of Virginia. Mr. Coakley advised that Henrico County voters were not subject to intimidation at the polls by national vote-monitoring organizations such as True the Vote.

Mr. Kaechele remarked that Mr. Coakley and his staff had compiled an impressive volume of infonnation for the Board on very short notice. Mr. Thomton complimented Mr. Hazelett for working with Mr. Coakley to establish high expectations for local voting procedures and to help ensure that the elections were conducted on a professional level. Mr. Hazelett commented that he was very pleased with how Mr. Coakley and his staff handled the election and how they responded to problems and concerns that were brought to their attention.

The Board recessed for ditiner at 6:08 p.m. and reconvened at 6:18 p.m.
