PUBLIC HEARING

RESOLUTION – Adoption of Operating and Capital Annual Fiscal Plans for Fiscal Year 2013-14 and Allocation of Car Tax Relief for Tax Year 2013.

On Tuesday, April 9, 2013, this paper will be considered, but should be deferred (at least seven days, according to law) before being approved. At a scheduled meeting on Tuesday, April 23, 2013, at 7:00 p.m. the proposed Operating and Capital Annual Fiscal Plans may be approved, amended, substituted for, or deferred until a later date, but, at least with regard to the schools' budget, should be approved by May 1, 2013. This paper will also allocate car tax relief for tax year 2013.

PROCLAMATION - Library Week - April 14 - 20, 2013.

The American Library Association has sponsored National Library Week annually since 1958 to celebrate the contributions of our nation's libraries and promote library use and support. This ordinance will vacate a portion of an alley easement adjacent to Lot 1, Block C of Treboy Avenue Subdivision near Willow Lawn.

The owner of Lot 1 has requested the vacation. There are no existing or planned County facilities in the easement. The vacation will resolve a zoning setback violation created by a shed and greenhouse located too close to the rear of the property.

RESOLUTION – Authorization to Apply for and Accept a Multi-Year Grant from Virginia Commonwealth University to Participate in a Clinical Trial of Pre-hospital Use of Plasma for Traumatic Hemorrhage.

This Board paper authorizes the County Manager to apply for and accept an allocation of grant funding totaling approximately \$432,863 from Virginia Commonwealth University ("VCU"). This grant, which requires no local match, will be used by the Division of Fire to participate in a clinical trial evaluating the use of blood plasma in the pre-hospital EMS setting. This trial is being funded by the U.S. Army and the primary recipient of grant funding is VCU; Henrico County will be a sub-recipient of funds from VCU.

This clinical trial is expected to begin in July 2013 and continue for approximately three years. The initial estimate of grant funds to be allocated to Henrico County totals \$432,863. This amount is estimated and may be increased based on the clinical trial progress.

The estimated grant funding as follows:

Year One:		164,559
Year Two:		134,152
Year Three:		134,152
Total:	\$	432,863

This funding will be used to cover a portion of the salaries of advanced life support EMS supervisors and all associated operating and capital expenses required to implement the clinical trial.

RESOLUTION - Acceptance of Roads.
