PUBLIC HEARING ITEMS

ORDINANCE - Vacation of Rights-of-Way and Easements - Suburban Apartments - Brookland District.

This ordinance will vacate portions of the rights-of-way and easements dedicated on the plat of Suburban Apartments. The subdivision is located west of Staples Mill Road and is being developed as part of Libbie Mill.

The owners of all the land shown on the plat have requested the vacation. There are no existing or planned County facilities in the areas to be vacated except for a drainage pipe in Crestwood Avenue for which an easement will be reserved.

The Real Property Department has processed this request through the Departments of Planning, Public Utilities, and Public Works without objection.

ORDINANCE - Vacation of Easements, Building Lines, Lot Lines, and Right-of-Way for Lacv Lane - Westbourne, Revised Plan of Section C - Brookland District.

This ordinance will vacate all easements, building lines, lot lines, and the right-of-way for Lacy Lane shown on the plat of Westbourne, Revised Plan of Section C. The subdivision is located west of Staples Mill Road and is being developed as part of Libbie Mill.

The owners of all lots shown on the plat have requested the vacation. There are no existing or planned County facilities in the areas to be vacated.

The Real Property Department has processed this request through the Departments of Planning, Public Utilities, and Public Works without objection.

RESOLUTION - Signatory Authority - Quitclaim of Utility Easements - Libbie Mill - Brookland District.

This resolution authorizes the Chairman to execute a quitclaim deed releasing the County's interest in unneeded utility easements across property west of Staples Mill Road that will be developed as Libbie Mill to the landowners, Arch Creek Venture, LLLP, GGC Associates, LLC, and Midtown Land Partners, LLC.

The Directors of Public Utilities, Planning, and Real Property recommend approval of this Board paper, and the County Manager concurs.

RESOLUTION – Appropriation of Funds for Fiscal Year 2013-14.

This Board paper appropriates funds for the operating and capital Annual Fiscal Plans for fiscal year 2013-14 approved by the Board of Supervisors on April 23, 2013.

This Board paper also reappropriates to fiscal year 2013-14 (i) funds for ongoing capital projects, (ii) funds budgeted in fiscal year 2012-13 for the long-term disability benefit, and (iii) funds for all valid outstanding encumbrances as of June 30, 2013. These funds are reappropriated to the same department and account for which they are originally appropriated or encumbered.

RESOLUTION - Signatory Authority - Amendment to Sublease - Capital Area Workforce Center - Chesterfield County, Virginia.

This Board paper authorizes the County Manager to execute a sublease amendment between the County and the Commonwealth of Virginia for additional space at the Capital Area Workforce Center at 7333 Whitepine Road in Chesterfield County. The County leases 10,000 square feet from FP Chesterfield, ABEF, LLC for service delivery to clients under the Workforce Investment Act of 1998.

The amendment will increase office space for the Virginia Department of Aging and Rehabilitative Services from 1,064 to 1,252 square feet, and the monthly rent will increase from \$4,828.58 to \$6,013.24, effective July 1, 2013. The sublease will end on July 31, 2014 when the master lease terminates.

The Directors of the Capital Region Workforce Partnership and Real Property recommend approval of this action, and the County Manager concurs.

RESOLUTION - Award of Construction Contract - Wedgewood Avenue Sewer and Water Replacement - Brookland and Fairfield Districts.

This resolution awards a contract to G.L. Howard, Inc. to replace approximately 2,750 linear feet of 8-inch diameter vitrified clay sewer piping, 11 standard manholes, 71 sewer service connections, approximately 500 linear feet of 6-inch diameter water main, 14 water service lines, and approximately 195 linear feet of 24-inch diameter storm sewer pipe.

The purpose of the project is to maintain the reliability of the sewer system in the area by rehabilitating deteriorated piping systems installed in the early 1950s. The water main (installed in the early 1950s) and the storm sewer are directly on top of, and in conflict with, the sanitary sewer and must be replaced due to the proposed sewer construction. The work is anticipated to begin in August 2013 and to be completed by May 2014. Funding to support the contract is available within the Water and Sewer Enterprise Fund.

Three bids were received on May 21, 2013 in response to IFB # 13-9400-4CE and Addendum No. 1:

G.L. Howard, Inc. is the lowest responsive and responsible bidder.

This resolution authorizes the County Manager to execute the contract in a form approved by the County Attorney. The County Manager, or the Acting Director of General Services as his designee, would also be authorized to execute change orders within the scope of the project budget not to exceed 15% of the original contract amount.

The Director of Public Utilities and the Acting Director of General Services recommend approval of this Board paper, and the County Manager concurs.

RESOLUTION - Acceptance of Roads.

This Board paper would accept the following named and described sections of roads into the County road system for maintenance.

- 1) 0.32 miles of Estates at Grey Oaks, Section 2. Three Chopt District.
- 2) 0.06 miles of Ashburn at Maple Ridge, Section 1. Varina District.

The Director of Public Works recommends approval of this Board paper, and the County Manager concurs.
