Summary of Actions Taken by the Board on January 28, 2014

The Board approved the minutes of the January 14, 2014, Regular Meeting; and March 18 – 21, 2013, Special Meeting.

MANAGER'S COMMENTS

Last month, Henrico County's Department of Social Services, along with adoption worker Mary Coleman, received a Governor's Adoption Award for their dedication to the families and children who are brought together by adoption of children in foster care. In the last year of his term, former Governor Bob McDonnell initiated a successful statewide effort to find families for the 1,000 children available for adoption in the statewide foster care system. The County's Department of Social Services was one of only a handful of public and private agencies to receive an agency award at a ceremony held on December 16, which included the participation of both Governor McDonnell and then Governor-elect Terry McAuliffe. The importance of the County's contributions towards achievement of the statewide adoption goal has also been recognized by the Henrico Circuit Court and Judge Gary Hicks in their continued practice of holding celebrations for families that adopt children from foster care. Deputy County Manager for Community Services Jane Crawley, Social Services Director Cindee Steinhauser, Assistant Social Services Director Shawn Rozier, Adoptions Supervisor Jim Carey, adoption workers Mary Coleman and Jamie Anderson, and other Department of Social Services staff members are to be commended for showing their dedication to these families and children and achieving recognition from the governor.
