#### **RESOLUTION – Abandonment of Portion of Old Pump Road – Three Chopt District.**

Approval of this resolution will abandon 4,805.19 square feet of Old Pump Road at its intersection with Church Road. The abandonment is a part of the settlement with the adjacent owners, John C. and Kathryne K. Zehler and Tommy L. England, for acquisition of right-of-way and easements for the John Rolfe Parkway Project. The settlement was approved by the Board at its September 25, 2010 meeting. The new road serves the same citizens that used the old road. The Directors of Real Property and Public Works recommend approval of this resolution; the County Manager concurs.

# INTRODUCTION OF RESOLUTION – Receipt of Requests for Amendments to the FY 2013-14 Annual Fiscal Plan: June, 2014.

Pursuant to Virginia Code Section 15.2-2507, amendments to the County's approved budget in excess of one percent of the County's currently adopted budget may be approved only after publishing a notice of a public hearing at least seven days before the hearing date. The budget amendments that are the subject of this paper fall under the one percent threshold that triggers the advertised public hearing requirement; nevertheless, this paper calls for their advertisement. The notice states the County's intent to amend the budget. To that end this paper is submitted, along with a list of the requested amendments, as an introduction, so the Board may authorize the advertising for June 3, 2014 and the public hearing for June 10, 2014. A separate paper will be submitted for Board action to amend the Annual Fiscal Plan and appropriate funds for expenditure, as applicable, after the June 10, 2014 public hearing.

### **RESOLUTION - Award of Construction Contract - Varina Area Library - Varina District.**

This Board paper would award a construction contract to Kenbridge Construction Co., Inc. for \$15,100,000 to construct the new Varina Area Library. The construction is anticipated to begin in June 2014.

The County received 13 bids on April 30, 2014 in response to IFB No. 14-9555-2JK and Addenda Nos.1, 2, 3, 4 and 5, as follows:

As permitted by state law and the bid documents, MGT Construction Management, Inc. withdrew its bid because of a clerical error. Therefore, the Board paper would award the contract to Kenbridge Construction Co., Inc., the lowest responsive and responsible bidder. It also authorizes the County Manager, or the Purchasing Director as his designee, to execute change orders not to exceed 15% of the original contract amount.

The Director of General Services, Director of Libraries, and Purchasing Director recommend approval of this Board paper, and the County Manager concurs. Funding to support the contract is available within the project budget.

#### **RESOLUTION - To Accept 2014 Virginia H.E.A.T. Program Award.**

This Board paper accepts a \$3,052 grant from the Virginia Help Eliminate Auto Theft (H.E.A.T.) Program. The Police Division will use this grant, which requires no local match, to send two auto theft detectives to the Southeast Regional International Association of Auto Theft Investigators Training in June 2014 in Mobile, Alabama.

INTRODUCTION OF ORDINANCE – To Amend and Reordain Section 17-1 Titled "Definitions," Section 17-23 Titled "Use generally," Section 17-24 Titled "Disposal of certain substances prohibited," Section 17-25 Titled "Dumping waste on premises other than sanitary landfills," and Section 17-58 Titled "Charges" of the Code of the County of Henrico, and to Change the Title of Article II of Chapter 17 From "Sanitary Landfills" to "County Household Refuse Disposal Areas," All to Reflect the Closing of the Springfield Road Landfill and to Change Requirements for County Refuse Disposal.

This Board paper would introduce for advertisement and a public hearing on June 24, 2014 a proposed ordinance to amend provisions of Chapter 17 of the Henrico County Code related to solid waste.

The proposed ordinance eliminates charges for waste disposal by commercial users because of the closure of the Springfield Road Landfill. In addition, the ordinance clarifies the charges for the use of 95 gallon refuse containers known as Supercans in the County's refuse collection service.

The Director of Public Utilities recommends approval of this Board paper, and the County Manager concurs.

# **RESOLUTION - Award of Construction Contract - CSX Transportation, Inc. - Charles City Road Improvement Project - Varina District.**

This Board paper would award a sole source contract for \$530,602 to CSX Transportation, Inc. ("CSX") to provide a new concrete railroad crossing, new signal devices and gates, and other related improvements at the crossing of Charles City Road and Spur Track DOT#224 296. CSX is the sole source for this contract because the improvements will be constructed on CSX's property.

The improvements are part of a project to widen Charles City Road between Lewis Road and Lisle Road, which the Board of Supervisors found necessary by resolution on March 22, 2011.

The Department of Public Works will deposit funds with CSX to be drawn down by CSX during the progress of the work.

The Board paper also authorizes the County Manager, or the Purchasing Director as his designee, to execute the contract.

The Director of Public Works and Purchasing Director recommend approval of the Board paper, and the County Manager concurs.

#### **RESOLUTION - Acceptance of Road - Fairfield District.**

This Board paper would accept the following named and described section of road into the County road system for maintenance.

1) 0.15 miles of Turner Mountain, Section 1. Fairfield District.

The Director of Public Works and the County Manager recommend approval of this Board paper.
