MANAGER'S COMMENTS

There were no comments from the Manager.

BOARD OF SUPERVISORS' COMMENTS

Mr. Schmitt noted he and other members of the Board had an opportunity to attend County public safety promotional and awards ceremonies since the Board's last meeting in December. There were 14 promotions within the Sheriff's Office and eight within the Division of Fire as well as more than 150 individual recognitions of service for Division of Fire personnel. Mr. Schmitt congratulated and thanked the public safety officials who were promoted and recognized.

Mr. Rapisarda assumed the Chair to conduct the election of the new Chairman of the Board of Supervisors. He called for nominations for the office of Chairman, and Mr. Branin nominated Mr. Nelson. After receiving the oath of office from Mr. Lawrence, Mr. Nelson presented a gift to Mr. Thornton on behalf of the Board acknowledging Mr. Thornton's service as Chairman during 2018. Mr. Nelson thanked Mr. Thornton for his leadership as Chairman and for his many years of service representing the Fairfield District. He pointed out it has been a pleasure sitting with Mr. Thornton as Vice Chairman during Mr. Thornton's past two terms as Chairman.

Mr. Nelson began his acceptance remarks by citing the following quote from U.S. Senator Amy Klobuchar: "As elected officials, we were sent to the halls of government by our neighbors to do their work, and much work needs to be done. Remembering our shared experiences with the people we represent makes us better and more accountable civil servants." He thanked the Board for electing him Chairman and pointed out he is looking forward to working with each member. Mr. Nelson highlighted County accomplishments and programs during 2018 in the areas of finance, family life and education, community-focused investments, recreation and tourism, development, public safety, and workforce. He expressed excitement about the community he represents and the team he works with as well as the County Manager, County staff, and his colleagues on the Board. Mr. Nelson also expressed excitement regarding the 2019 calendar year, during which work will begin on new facilities for J.R. Tucker and Highland Springs High Schools, a Henrico aquatics center, upgrades to Dorey and Glover Parks, and a new elementary school in the Brookland District. He concluded his remarks by referring to plans for resolving the issue of salary compression for general government and school employees, completing the procurement process for a new indoor sports facility, embarking on an ambitious residential repaving program, addressing opioid addiction through a multi-agency treatment effort, and continuing to work with the School Superintendent and School Board to improve the outcomes of local schools.
