# **RESOLUTION** - Concurrence in Chairman's Designation of Member of Central Virginia Transportation Authority.

The 2020 General Assembly established the Central Virginia Transportation Authority ("Authority"), effective July 1, 2020.

Under the legislation, a locality's chief elected officer is automatically a member of the Authority for a term coincident with the officer's term of office.
