### PUBLIC HEARING ITEMS

# ORDINANCE - To Reduce the Effective Tax Rate for Qualifying Vehicles in 2022 by Returning Surplus Personal Property Tax Revenues for Qualifying Vehicles to Taxpayers.

This ordinance would reduce the effective personal property tax rate for qualifying vehicles from \$3.50 to \$2.98 per \$100 of assessed value for 2022. The tax rate would be reduced by providing taxpayers a credit of \$0.52 per \$100 of assessed value for qualifying vehicles assessed personal property taxes for some or all of 2022. The credit would be provided from surplus personal property tax revenues for FY 2021-22 and reflected on the second-half installment bills due on December 5, 2022. Credits may also be applied to supplemental bills after December 5 when appropriate.

Under the ordinance, qualifying vehicles include automobiles, trucks, and motorcycles classified by Section 58.1-3503(A)(3), (4), (5), and (10) of the Code of Virginia and assessed personal property taxes in the County for some or all of 2022. Qualifying vehicles would not include tax-exempt vehicles or vehicles taxed at a rate of \$1.00 or less per \$100 of assessed value.

The Director of Finance recommends approval of the Board paper, and the County Manager concurs.

### **RESOLUTION** - Signatory Authority - Lease of County Property - 9170 Willis Church Road - Varina District.

This Board paper authorizes the County Manager to execute a deed of lease with Christen Nicole Motley for the single-family dwelling at 9170 Willis Church Road. The lease would be for a two-year term beginning August 1, 2022 and ending July 31, 2024. Ms. Motley will pay a monthly rent of \$900.00 and perform routine maintenance of the dwelling. The parties may agree to renew and extend the lease term. Ms. Motley is the daughter of William Motley, Jr., an employee of the County's Recreation and Parks Division. Mr. Motley has not participated in the negotiation of this lease in his official capacity.

The Directors of Real Property and Recreation and Parks recommend approval of this Board paper; the County Manager concurs.

### **INTRODUCTION OF RESOLUTION - Receipt of Requests for Amendments to FY 2022-23 Annual Fiscal Plan - July 2022.**

This Board paper introduces for advertisement and a public hearing on August 9, 2022, a resolution to amend the annual fiscal plan for FY 2022-23. The requested amendments are shown in a list dated July 19, 2022, provided by the County Manager to the Board.

Pursuant to Virginia Code Section 15.2-2507, the County may amend its budget to adjust the aggregate amount to be appropriated during the current fiscal year. Amendments that exceed one percent of the total expenditures shown in the currently adopted budget must be accomplished by publishing notice of a meeting and public hearing once in a newspaper having general circulation in the County at least seven days prior to the meeting date. The notice states the intent of the Board of Supervisors to amend the budget and includes a brief synopsis of the proposed budget amendments.

The Director of Finance recommends approval of the Board paper, and the County Manager concurs.

## **RESOLUTION** - Determination Required for Virginia Housing Financing of Virginia Center Commons Apartments - Fairfield District.

This Board paper would make two determinations required by state law for Virginia Housing (formerly VHDA) financing of a proposed apartment complex of up to 275 units at the Virginia Center Commons Mall, 10101 Brook Road, Glen Allen, Virginia. The proposed project would increase the availability of affordable housing in the County because the Virginia Housing financing would require the applicant to lease at least 20% of the dwellings to persons earning less than 80% of the area median income.

The Director of Community Revitalization recommends approval of the Board paper; the County Manager concurs.

### **RESOLUTION** - Award of Contract - SCADA System Replacement Operations Center and Remote Sites Project.

This Board paper awards a fixed price contract for \$6,953,767 to Clark Construction Group, LLC for the SCADA System Replacement Operations Center and Remote Sites Project. The Project consists of replacing the existing supervisory control and data acquisition ("SCADA") system. The County's SCADA system monitors and controls equipment in the water and sewer pump stations by gathering and analyzing real time pressure and flow data to advise operators when equipment or processes are not operating correctly.

Work on the Project is anticipated to begin October 2022 and be completed within 912 calendar days. Funding will be provided by the Water and Sewer Revenue Fund.

The County received one bid on June 28, 2022, in response to ITB 22-2336-4JL and Addenda Nos. 1, 2, and 3. The bid was as follows.

### <u>Bidder</u>

Clark Construction Group, LLC - Bethesda, MD

Bid Amount \$6,953,767

Based upon a review of the bid, Clark Construction Group, LLC is the lowest responsive and responsible bidder.

Funding to support the contract is available within the project budget. The Director of Public Utilities and the Purchasing Director recommend approval of the Board paper, and the County Manager concurs.
