Update on Opioid Abatement Funding

Mike Feinmel, Deputy County Manager for Public Safety, gave the Board an update on opioid litigation and funding affecting the County. He noted that Henrico filed suit in January of 2020, along with 80 other Virginia counties and cities, against several defendants alleging negligent conduct in the marketing, supply, and sale of prescription opioids.

Mr. Feinmel explained that settlements in the litigation will result in significant funding for the County to be dedicated to opioid abatement. He reviewed the distribution of the settlement funds, including funding through the Virginia Opioid Abatement Authority (VOAA). He noted the VOAA is offering a financial incentive to localities that agree to adopt best practices in the management of settlement funds. Mr. Feinmel reviewed Henrico's potential funds going through FY2039 and promised to bring forward recommendations on the use of funds to the Board at the Retreat next month.
