Prior to the start of the Work Session, Mr. Vithoulkas recognized Terrell Hughes, Director of Public Works, and his team. #### Update on Regency Square and Virginia Center Commons

Mark Slusher, with Thalhimer Realty Partners, Inc. and Rob Hargett, with the Rebkee Company, briefed the Board on what was currently happening at Regency Square Mall and Virginia Center Commons Mall. Mr. Slusher shared an overview of what Regency looked like when it was built in 1975 and how it looked up until 2015 when the mall was purchased. He then showed the current improvements on the property and the plans for more improvements through 2030. Mr. Slusher concluded his portion of the presentation by thanking the Board and the Manager for the strong partnership because, without that, he would never have been able to implement the vision for a strong, redeveloped Regency. At this point, he turned the presentation over to Rob Hargett to give an update on Virginia Center Commons.

Mr. Hargett shared an overview of the Virginia Center Commons Mall project. He showed the development to date and the planned additional improvements, including hotels, restaurants,

housing, and more. He shared the same sentiments as Mr. Slusher about the partnership with the Board and the Manager and looks forward to the continued partnership.

Ms. Tretina announced the second item on the Work Session agenda, the North Gayton Road Interchange update, would be rescheduled for another date.
