Dear Mr. Sledd:

The Board of Supervisors at its meeting on May 9, 2023, approved your request to amend proffers accepted with C-35C-91 on Parcel 753-759-5245 located approximately 400' from the northwest intersection of W. Broad Street and Stillman Parkway, described as follows:

Beginning at a point, said point being 778.30' from the intersection of the north line of W Broad Street (State Route 250) with the east line of Gaskins Road; thence, N 74°16'28" E for a distance of 50.10' to a point; thence, N 32°24'55" E for a distance of 99.11' to a point; thence, N 04°27'16" W for a distance of 17.50' to a point; thence, N 57°35'05" W for a distance of 194 14' to a point; thence; N 32°24'55" E for a distance of 243.25' to a point; thence, R 57°35'05" W for a distance of 33.44' to a point; thence N 32°24'55" E for a distance of 291.67' to a point; thence, S 57°35'05" E for a distance of 419.51' to a point; thence, S 32°37'20" W, for a distance of 387.69' to a point; thence S 57°24'30" E for a distance of 81.72' to a point; thence, S 32°37'20" W for a distance of 41.06' to a point; thence along a curve to the left having a radius of 119.00' and an arc length of 79.64', being subtended by a chord of N 76°33'05" W for a distance of 78.17' to a point; thence along a curve to the right having a radius of 301.00' and an arc length of 142.96', being subtended by a chord of N 82°07' 06" W for a distance of 141.62' to a point; thence, S 62°07'58" W for a distance of 15.83' to a point; thence, S 32°24'55" for a distance of 122.08' to a point; thence, S 08°54'12" E for a distance of 48.69' to a point on the north line of W. Broad Street; thence along the north line of W Broad Street, N 57°27'07" W for a distance of 116.58' to a point and being the point of beginning, as shown on plat by Foster & Miller, PC, dated February 22. 1993, entitled "Plat of 5.134 Acres 'With Improvements, located on the North Line of W Broad Street, Three Chopt District, Henrico County, Virginia" a copy of which is attached to and made a part of the deed recorded in Deed Book 2436, page 396, reference to which is hereby made for a more particular description of said land.

The Board of Supervisors accepted the following proffer amendments, dated April 11, 2023, which further regulate the above-described property in addition to all applicable provisions of Chapter 24, Code of Henrico (Zoning Ordinance):

All conditions of rezoning case C-35C-91 will apply to the subject property except as revised below.
