The Henrico County Division of Police will hold a rabies clinic at the Public Safety Fair on Saturday, October 14, from 10 a.m. to 3 p.m., at the Public Safety Building, 7721 E. Parham Road.

Rabies shots cost \$6 each and come with a certificate of inoculation and a rabies tag. Dog owners may also purchase a license for the current year as well as 2001 at the clinic for \$10 but must show proof of rabies inoculation. All dogs and cats ages 4 months and older are required to have a rabies shot.

Henrico County's Bond Referendum 2000 will be the topic of discussion at Board Chairman and Fairfield District Supervisor Frank Thornton's next constituent meeting on Monday, October 9, at 7 p.m., at Wilder Middle School, 6900 Wilkinson Road.

Representatives from the county's Department of Finance, Schools, Public Works, Libraries, Fire and Recreation and Parks will join Thornton to explain the bond process and answer questions.

On Election Day, Tuesday, November 7, Henrico voters will decide whether to approve the referendum. If approved, these bonds will allow the county to finance projects that have no alternative source of funding.

Thornton's meetings are open to the public; he encourages anyone interested in learning more about the bond referendum to attend.
