Henrico County encourages eligible taxpayers to apply for real estate tax relief through its Real Estate Advantage Program (REAP).

To qualify for REAP, participants must be age 65 and older, or permanently and totally disabled; gross annual household income cannot exceed \$35,000; and the net combined financial worth of the applicant and any co-owners of the home cannot exceed \$125,000.

"This program receives a lot of positive feedback from the community and saves eligible taxpayers an average of \$500 each year; however, we would like more people to utilize the program," said Management Specialist Leo Marsh.

A complete application and documentation from all sources of income and net worth must be filed with the county's Revenue Division by April 2, 2001. To receive an application and a detailed brochure, please call 501-4263.
