The next constituent meeting of Fairfield District Supervisor Frank Thornton will offer an update on legislative activities of the Virginia General Assembly and will also provide information about Henrico County's mailing address-change initiative. The meeting is scheduled for 7 p.m. Monday, March 10 at Belmont Recreation Center, 1600 Hilliard Road.

Delegate Joe Morrissey will discuss the 2008 session of the General Assembly and will join Thornton for a question-and-answer period as well.

In addition, Deputy County Manager Leon Johnson will answer questions about the ongoing effort to change county mailing addresses from "Richmond, VA" to "Henrico, VA." The county is working with the U.S. Postal Service on the initiative, which would correct the misdirection of \$5 million in tax revenue to the city each year. Affected Henrico residents and businesses will vote on the issue in early May.
