## **Henrico leaf collection to start in November**

*Residents encouraged to keep leaves from blocking storm drains*

Henrico County will kick off its 2016-17 leaf-collection services Nov. 14 with several options to help residents maintain their yards and properties.

Free collection of bagged leaves is scheduled from Nov. 14 through Feb. 5. Crews will work week to week in five zones. Each area will receive two pickups, with the second cycle starting when the first one ends.

Collection is provided automatically for residents living in the designated zones; residents living outside those areas can place an order for free pickup by calling (804) 727-8770.

Bags of leaves should be free of trash and other debris and placed at the curb or road's edge by 7 a.m. on the Monday of the assigned pickup week. Any number of bags will be collected, but they must be accessible from the street as crews are not authorized to enter private property.

Henrico also will offer vacuum leaf service by request during two collection periods. A fall collection will occur from Nov. 14 through Dec. 31 followed by an early spring collection from Feb. 27 through March 31. Leaves should be placed at the curb or road's edge and be free of trash, sticks and other debris.

Residents can order the \$30 vacuum service at [henrico.us/utility](http://henrico.us/utility) or by calling (804) 501-4275.

Whether using the bagged pickup or vacuum service, residents are encouraged to avoid piling bags or loose leaves in traffic lanes, parking spaces, storm drains or ditches. In addition to creating a potential traffic hazard, misplaced leaves can block drainage and contribute to stormwater pollution, noted Mercer Cronemeyer, environmental inspector with Henrico's Department of Public Works.

"Leaves that get into our streams and waterways often contain dirt, pet waste and other contaminants, which have a negative impact on water quality," Cronemeyer said.

Henrico's public-use areas, located at 2075 Charles City Road and 10600 Fords Country Lane, offer residents another leaf-disposal option. Bagged leaves will be accepted at no cost from Nov. 14 through Feb. 5 and for \$3 per visit at other times. Loose leaves and other yard debris are accepted year-round at no charge. The public-use areas are open daily from 7:30 a.m. to 7 p.m. except for certain holidays.

Henrico's leaf collection program is a joint effort by the departments of Public Utilities and Public Works.

*Henrico to provide free flu shots Oct. 26*

The Henrico County Health Department will offer free flu vaccinations to the public Wednesday, Oct. 26 at clinics in western and eastern Henrico.

The seasonal flu shots will be provided from 11 a.m. to 7 p.m. at the Mount Vernon Adult Education Center, 7850 Carousel Lane in western Henrico and from 3 to 7 p.m. at the Henrico Theatre, 305 E. Nine Mile Road in eastern Henrico.

The vaccine will be available to individuals age 3 and older on a first-come, first-served basis. Nasal vaccine will not be offered at the clinics.

Flu, or influenza, is a serious disease that can be easily spread and lead to hospitalization and sometimes death, particularly in older adults. Flu season in the United States, when flu viruses are circulating at elevated levels, runs generally from early October through May. An annual seasonal flu vaccine is the best way to reduce the chances of infection, according to the U.S. Centers for Disease Control and Prevention.

*Henrico to offer rabies vaccinations for pets Oct. 15*

The Henrico County Police Division will provide rabies vaccines for dogs and cats from 9 a.m. to noon Saturday, Oct. 15 at the Henrico County Government Center, 4301 E. Parham Road.

Pet owners must register and pay at the cashier's office in the Administration Building before seeing a veterinarian on the first level of the adjacent parking deck.

Each vaccine costs \$10 and must be paid in cash. A rabies tag and certificate of inoculation are included. Pets from all localities are welcome. Cats must be in carriers.

Under Virginia law, dogs and cats 4 months of age and older must be vaccinated for rabies.

Henrico dog licenses will be available for \$10, for a one-year license, and \$15, for a three-year license. Officers will be available to discuss license options and vaccination requirements.

*Henrico launches Ask The Question campaign to prevent suicide*

Henrico Area Mental Health & Developmental Services (MH&DS) has launched a suicide-prevention campaign — Ask The Question — to encourage people to speak up if someone close to them appears in distress.

The campaign asks individuals to reach out with the simple question “Are you thinking about suicide?” if a friend, neighbor or loved one indicates that he or she might be contemplating such action. By initiating a dialogue, individuals can be directed to support services and other resources. The campaign, spearheaded by the Prevention Services unit of MH&DS, is using social media as well as advertisements on GRTC Transit System buses that will run through the end of 2016.

“This is a very vulnerable time of year for a lot of people,” said Dr. Patricia Hill, Prevention Services manager with MH&DS. “The message behind the Ask The Question campaign is to keep spreading information to save lives.”

The suicide rate peaks in the spring and the fall, according to the Centers for Disease Control and Prevention. Ask The Question encourages individuals to raise awareness and share their experiences using #ATQ16 on Twitter, Instagram and Facebook. A webpage, [henricoprevention.org/atq16](http://henricoprevention.org/atq16), provides links to information and resources, including a quiz, warning signs that someone may be experiencing mental health distress and access to the National Suicide Prevention Lifeline (1-800-273-8255) and other support organizations.

Each year in Virginia, three times as many people die by suicide than by homicide, and one person commits suicide every eight hours on average. Suicide also is the second leading cause of death for people ages 15 to 34 in the state.
