A. General Requirements.

1. All items in this solicitation shall be new products, free from defects. Used, refurbished or remanufactured equipment shall not be accepted.
2. All firearms and accessories shall be as specified. No substitutions will be allowed.
3. Bidders must be authorized distributors of the manufacturer(s) specified in this solicitation. Bidders shall provide a current Letter of Authorization on the specified manufacturer's letterhead with its bid certifying that the distributor is authorized to sell in the Commonwealth of Virginia. The Letter of Authorization shall contain manufacturer or distributor point of contact name, mailing address, phone number, email and if available, a re-seller identifier.
4. All unit prices shall be FOB destination to 6550 La France Road, Sandston, VA 23150 and include all shipping and freight charges (including fuel surcharges).
5. An initial order consisting of the quantities listed on the Bid Form for Lot A and Lot B shall be delivered by August 6, 2021.
6. Additional orders for these products will be placed annually for new recruit schools and/or replacement firearms on an if and when required basis for quantities determined at that time.
7. Bidders must provide pricing for all Bid Items in a Bid Item Lot to be considered for award.

- C. Specifications for Holsters.
 1. Safariland Duty Holster for Glock 17 Gen 5 with light. ALS Guard Model 7390-8325-411-AG-NH
 2. Safariland Off-Duty Holster for Glock 17 Gen 5 with light. Model 557 open-top belt slide concealment holster.
- D. Warranty.
 1. Successful Bidders shall provide the manufacturer's standard warranty for all components and equipment against defects following receipt by the Division of Police.
 2. During the warranty period, Successful Bidders shall guarantee to repair and/or replace all equipment as a result of defective material and cover 100% of the parts, labor and shipping. The Division of Police shall not be required to deal with warranty issues with anyone other than the Successful Bidder or the manufacturer.
 3. The Successful Bidder or the manufacturer shall provide a toll-free number for technical support and warranty claims. To minimize downtime as a result of faulty components and equipment, all warranty items shipped to the manufacturer must be repaired or replaced and shipped back to the Division of Police within 3 business days following receipt of the defective equipment by the manufacturer.
