This Goods Contract (this "Contract") entered into this 30th day of June 2022, by the County of Henrico, Virginia (the "County") and Badger Meter Inc., a Virginia corporation, and its successors it assigns (the "Contractor").

SCOPE OF CONTRACT: The Contractor shall furnish all materials, equipment, and labor necessary to provide inside delivery of Water Meters and Fire Hydrant Meters to the County as set forth in the Contract Documents.

COMPENSATION: The compensation the County will pay to the Contractor under this Contract shall be in Appendix A.

CONTRACT TERM: The Contract term shall be for a period of one year beginning July 1, 2022 and ending June 30, 2023. The County may renew the Contract for up to 4 additional one-year terms giving 30 days' written notice before the end of the term unless Contractor has given the County written notice that it does not wish to renew at least 90 days before the end of the term.

CONTRACT DOCUMENTS: This Contract hereby incorporates by reference the documents listed below (the "Contract Documents") which shall control in the following descending order:

- 1. This Goods Contract between the County and Contractor.
2. Invitation for Bid No. 22-2339-4MEJ, dated May 13, 2022 (as modified by any addenda).
3. The Contractor's bid dated June 9, 2022.
