This contract, made this 27th day of October, 2014 between the County of Henrico, hereinafter called the "County" and

WITNESSETH: That, for the consideration mentioned below, the Contractor promises to do all the work and/or furnish all the materials, equipment and/or labor necessary to carry out this agreement in the manner and to the full extent set forth in Invitation for Bid #14-9649-8RB dated September 9, 2014, to the satisfaction of the County. At all times the County shall have the right to inspect the Contractor's work performed under this agreement. All terms and conditions, specifications, general and special provisions, plans, drawings, and all documents referred to below are hereby made part of this agreement as completely as if incorporated herein.

It is agreed that the services to be done under this contract are to furnish all tools, labor, supervision and equipment necessary to deliver Automotive Batteries in accordance with: (i) Invitation for Bid #14-9649-8RB dated September 9, 2014, including the general terms, conditions and requirements therein; (ii) Contractor's bid dated October 8, 2014 . The agreement period shall be from December 1, 2014 through November 30, 2015 and may be renewed for Four (4) additional one year periods.

In consideration of the foregoing services, which consideration is acknowledged by the parties to be sufficient and complete for all of the work within the scope of this agreement, the County agrees to pay the Contractor for all items of work performed and/or materials furnished at the unit prices or lump prices under the conditions set forth in documents herein referred.
